






GRAPHS AND CHARTS

2012-2021 10-Year Comparison Data

The following graphs look at the last ten years of data from the Court for comparison purposes. Specifically, the following graphs depict the number of juveniles that were admitted to the Detention Services Center by complaint type, Delinquency Placements (children admitted to the Department of Children's Services Corrective Division), Dependency Placements (children admitted to the Department of Children's Services Protective Division), the number of juvenile complaints by type of complaint (delinquent, unruly, dependency, and other), the type of offenses (against persons, against property, and other delinquent offenses), the number of alcohol and drug related offenses, as well as the number of homicides that were committed by juveniles.

Juveniles Admitted to Detention by Complaint Type 2012 - 2021



Delinquent refers to any charge determined to be delinquent per TCA code.


Special refers to children who have delinquent charges and are held in the detention center for other agencies, such as DCS or other states.

Unruly refers to actions that are illegal simply because the alleged offender is a juvenile. These include Truancy, Illegal Use of a Telecommunications Device, Minor in Possession of Tobacco or Smoking and Violation of Curfew.

Runaway refers to all children who have run away from their primary residence.

Dependent & Neglected children include those children who have been victims of abuse or neglect by their caregivers.


Delinquent Placements 2012 - 2021



This graph represents the number of children, broken down by gender, that were adjudicated delinquent and committed to the Corrective Division of the Department of Children's Services.

Delinquent refers to any charge determined to be delinquent per TCA code.


Dependency and Neglect Placements 2012 - 2021



This graph refers to the number of children that were placed into the Protective Division of the Department of Children's Services.

Dependent & Neglected children include those children who have been victims of abuse or neglect by their caregivers.

Juvenile Complaints by Type 2012 - 2021







Types of Offenses 2012 - 2021




Delinquent Offenses refers to any charge determined to be delinquent per TCA code.

Homicides Committed by Juveniles 2012 - 2021




"Murder I & II" includes Murder I, Murder II, First Degree Murder in Perpetration of a Felony and Facilitation of First Degree Murder.




Traffic Information by Race, Age And Gender

The traffic information presented here relates to the traffic citations that were issued to juveniles for 2021 and are broken down by age, race, and gender. Age simply refers to the age of the child at the time of the referral to Juvenile Court. When looking at Race, this information is gathered from the child by self-identification. It should be noted that Juvenile Court only differentiates three (3) different racial types – Black, White, and Other. The Other category refers to any race other than Black or White, and includes children who identify as Hispanic. At this time, Juvenile Court only identifies two (2) genders; male and female.


Traffic Violators by Race 2021



Traffic Violators by Age 2021





Traffic Violators by Gender 2021



2021 Referrals of Children by Race and Gender







2021 Children* Referred to the Court (excluding children in the Summons Review Program) by Gender











2021 Children in the Summons Review Program (SRP) by Race and Gender




The Summons Review Program (SRP) is for children who receive either delinquent or unruly summonses ONLY.
