
Complaints by Month

The following graphs show four (4) different complaint types by month and gender. The complaint types are Delinquent, Unruly, Dependent & Neglected and Other. Delinquent complaints refer to any allegation that has been defined as delinquent per TCA code. These are offenses that are crimes for both children and adults. Unruly complaints refer to actions that are illegal simply because the alleged offender is a juvenile, such as truancy, violation of curfew, and minor in possession of tobacco. Runaway children are also counted here. Dependency and Neglect complaints refer to allegations in which the children are victims of abuse or neglect by their parent or guardian. Other complaints look at issues involving custody, visitation, school admissions, and traffic offenses not considered delinquent per TCA Code.


2021 Delinquent Complaints by Month and Gender

(without Summons Review Program (SRP) children)




2021 Delinquent Complaints by Month and Gender

(including Summons Review Program (SRP) children)




2021 Unruly Complaints by Month and Gender

(without Summons Review Program (SRP) children)






2021 Dependent & Neglected Complaints by Month and Gender




Other Complaints refer to Custody, School Admission, Visitation, and Traffic Charges that are not considered delinquent per TCA.


Type of Complaint by Gender and Age





2021 Males with Delinquent Complaints by Age (including Summons Review Program (SRP) children)




2021 Females with Delinquent Complaints by Age (including Summons Review Program (SRP) children)




2021 Males with Unruly Complaints by Age (without Summons Review Program (SRP) children)






2021 Males with Unruly Complaints by Age (including Summons Review Program (SRP) children)






