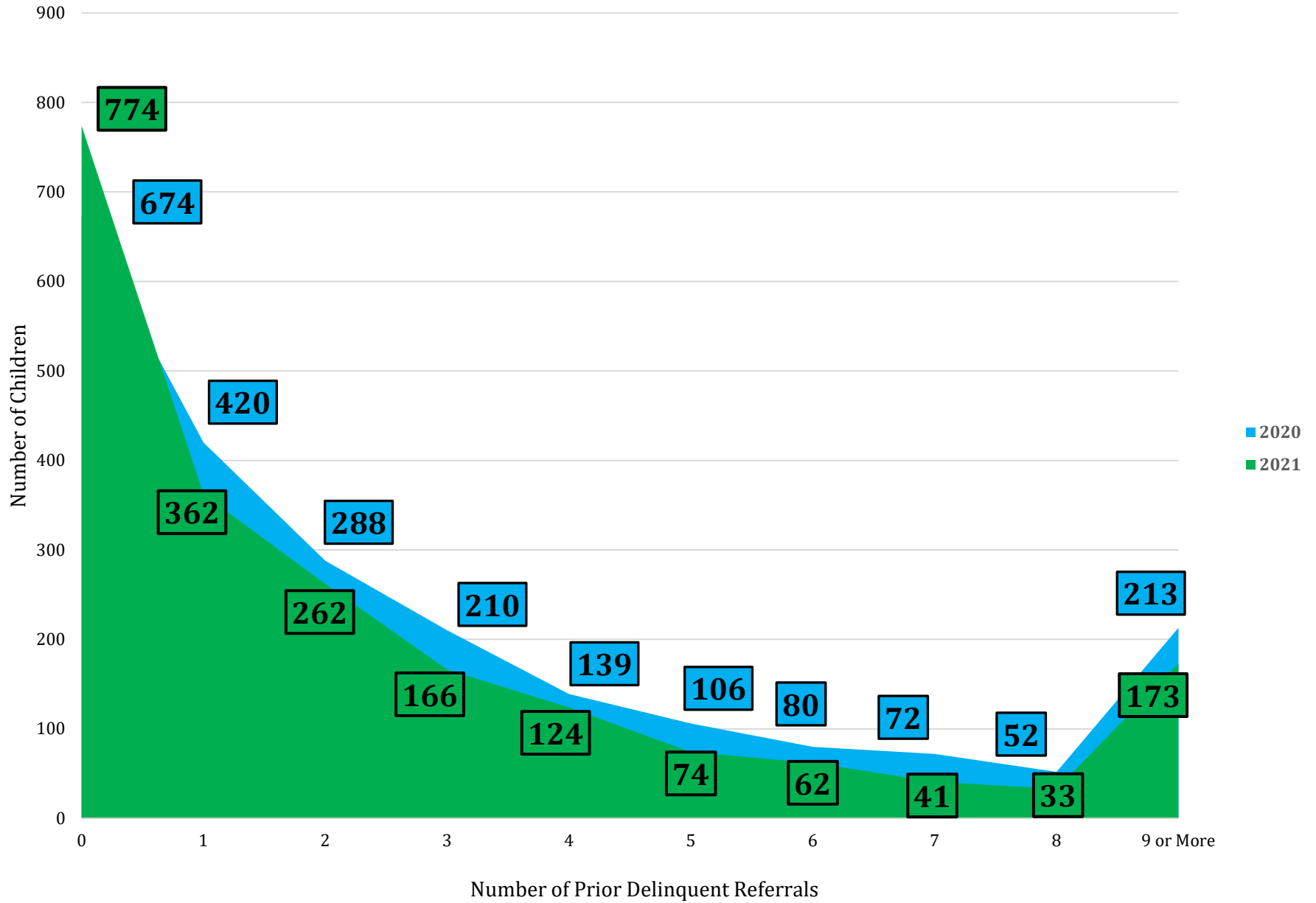


# 2020 vs 2021 Prior Delinquent & Unruly Referrals

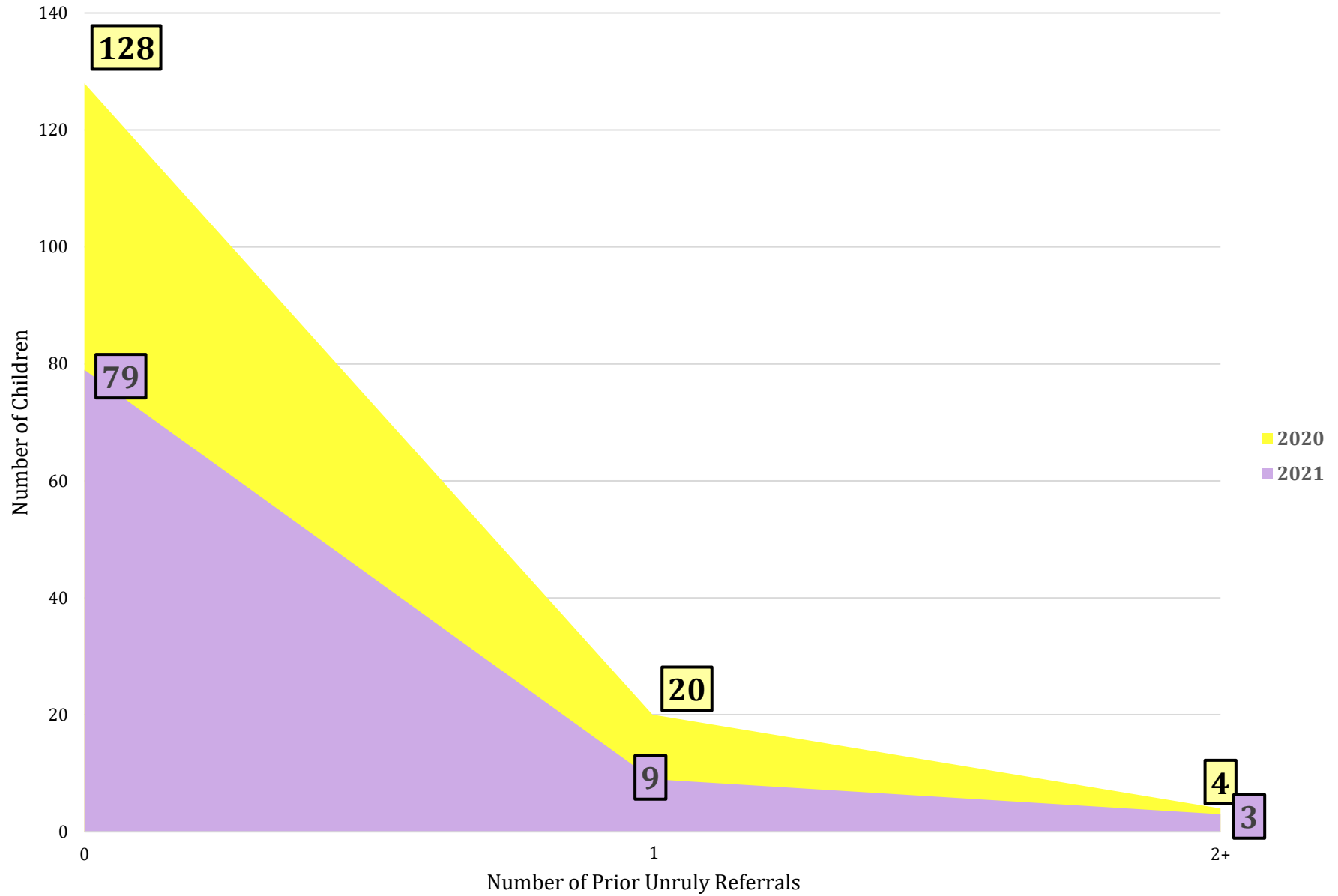
The two (2) following graphs depict the number of children referred to the Court for delinquent and unruly offenses and the number of prior delinquent and unruly referrals those children had, if any, to Juvenile Court. For example, in looking at the “prior Delinquent Referrals” graph, you can see that in 2021, 774 children referred to the court for a delinquent offense had no prior delinquent offenses, whereas 362 children referred to the court for a delinquent offense had one (1) prior referral for a delinquent offense.

### 2020 & 2021 Prior Delinquent Referrals

## 2020 & 2021 Prior Unruly Referrals



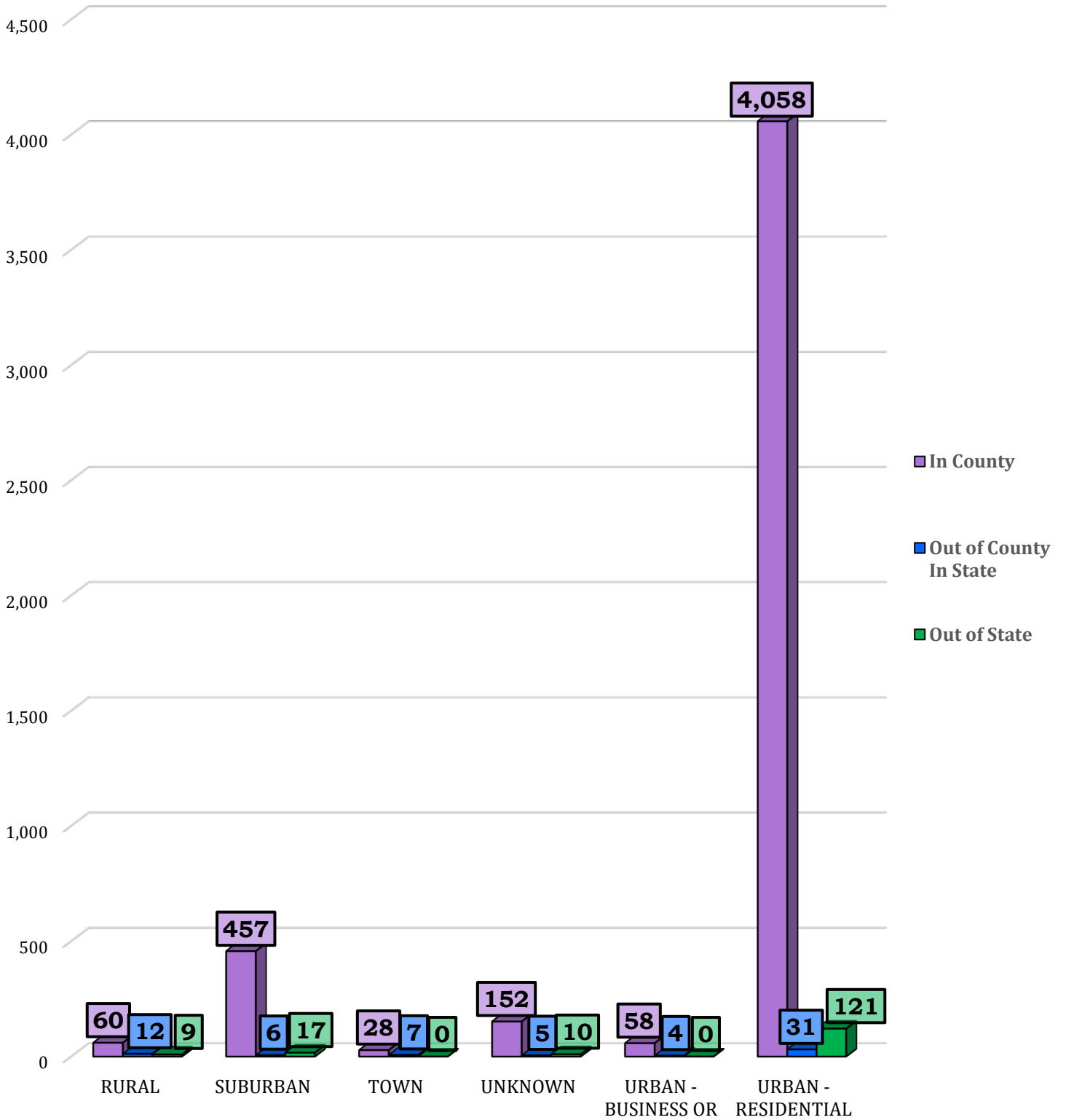

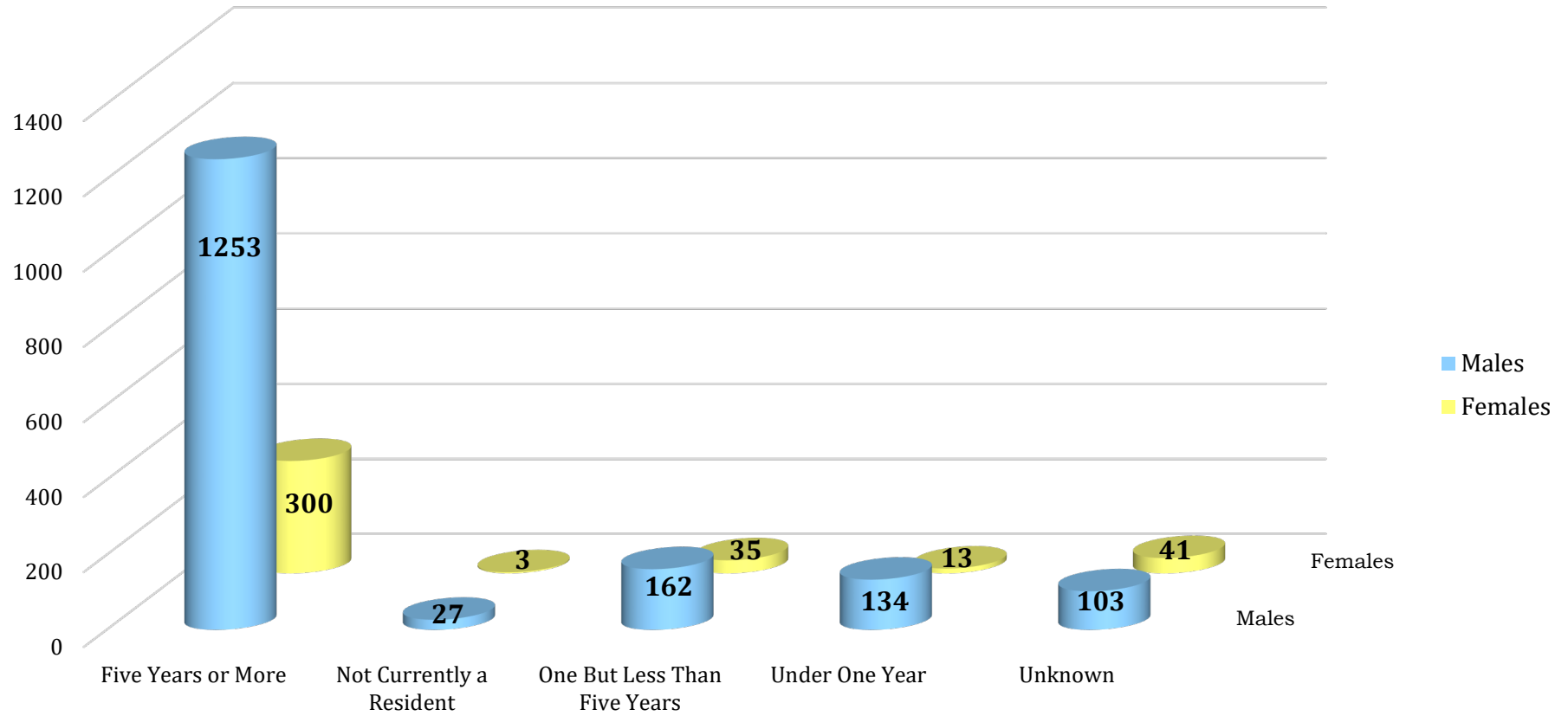
## Location of Residence and Length of Residence by Complaint Type and Gender

The graphs show the location of residence (rural, suburban, town, urban – business or industrial, urban – residential, or unknown) and whether the child resides in Shelby County, outside of Shelby County but within the state of Tennessee, or out of the state of Tennessee as well as the length of time the child has been in their current living arrangement by type of complaint and gender.

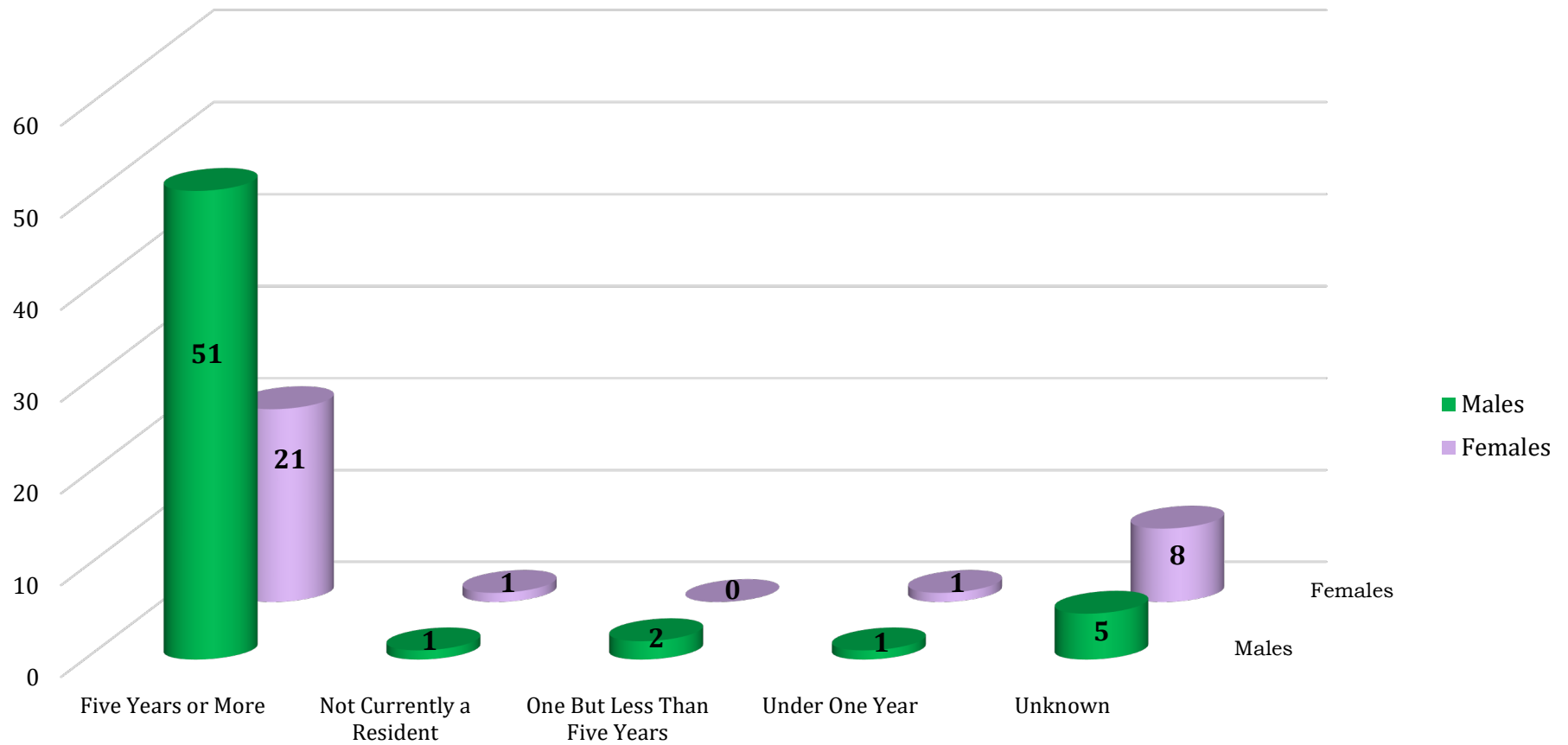

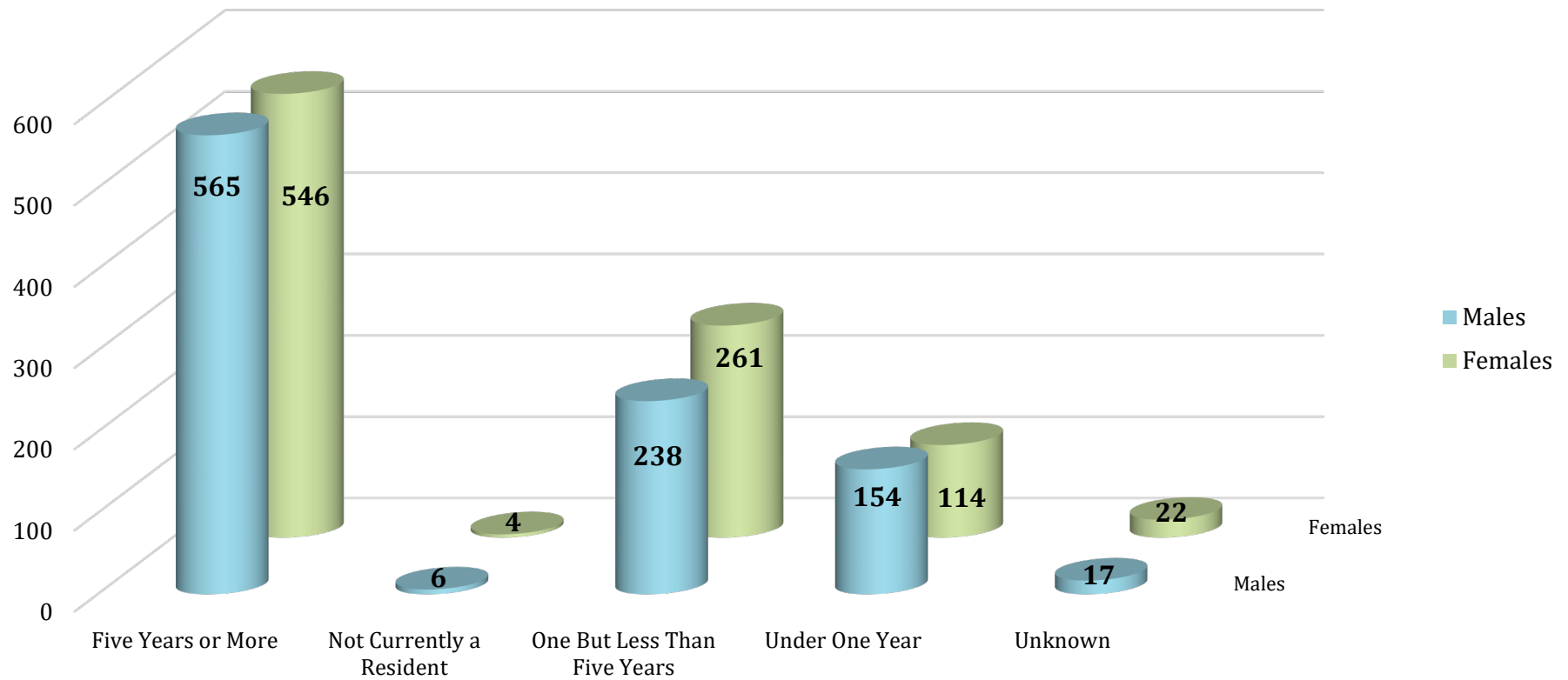

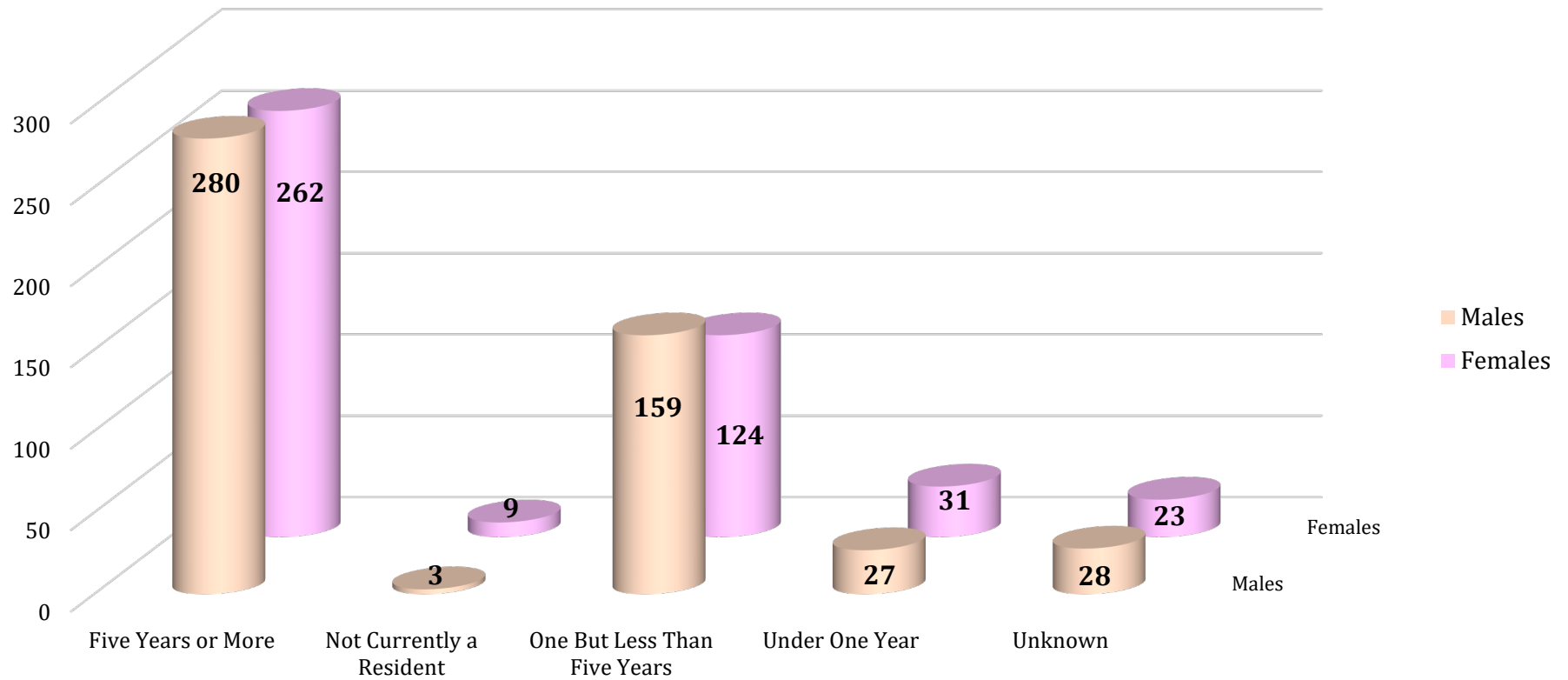

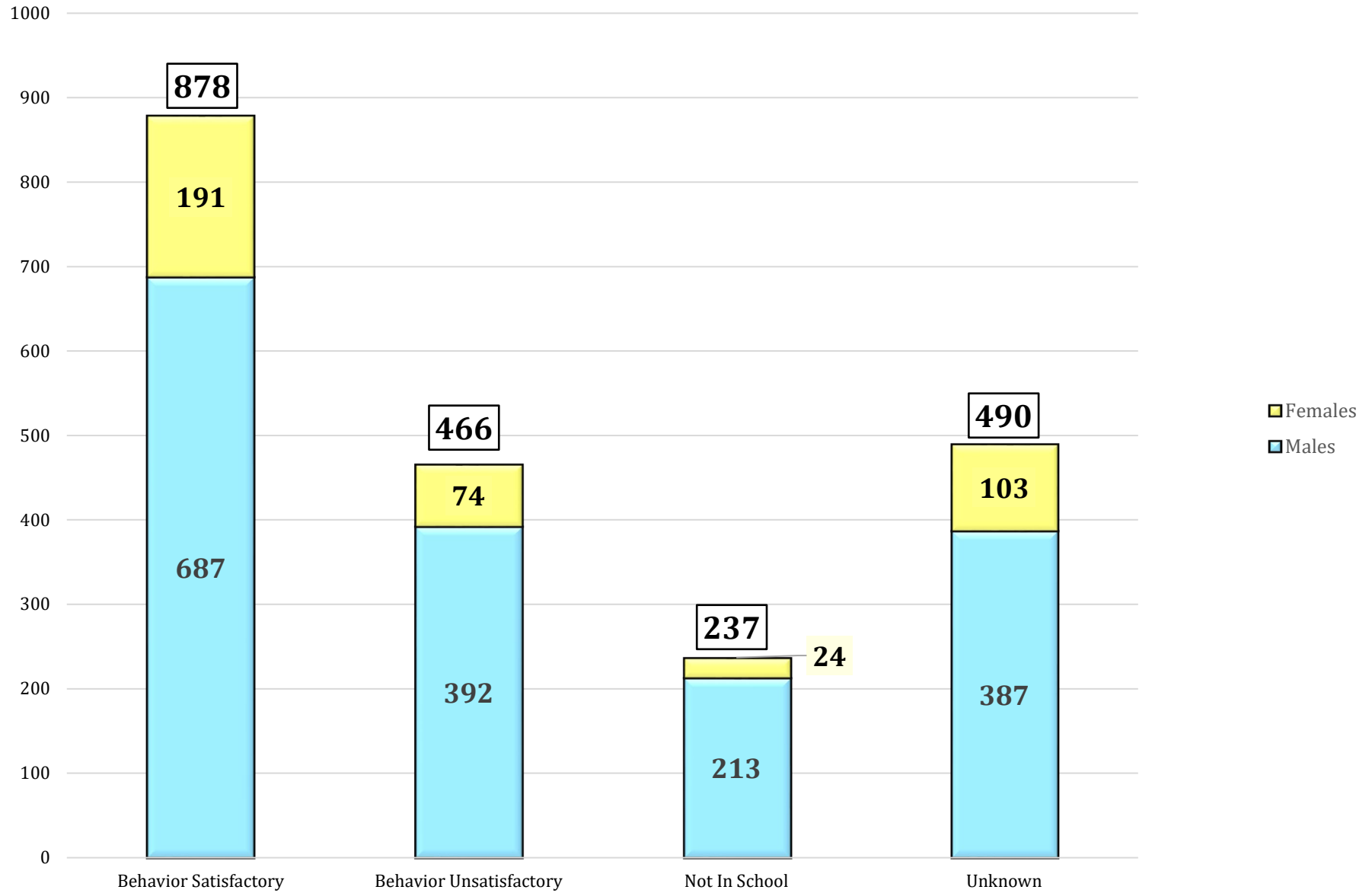

# 2021 School Behavior by Gender and Complaint Type

These graphs show the school behavior of children referred to Juvenile Court by type of complaint and gender. School Behavior is determined by whether the child has had any behavioral issues at school and/or conduct grades. Options include “satisfactory behavior” (no behavioral issues and/or good conduct grades), “unsatisfactory behavior” (behavioral issues and/or problematic conduct grades), “not in school” (the child is not enrolled in school), and “unknown” (there is no information available on the child’s behavior in school).

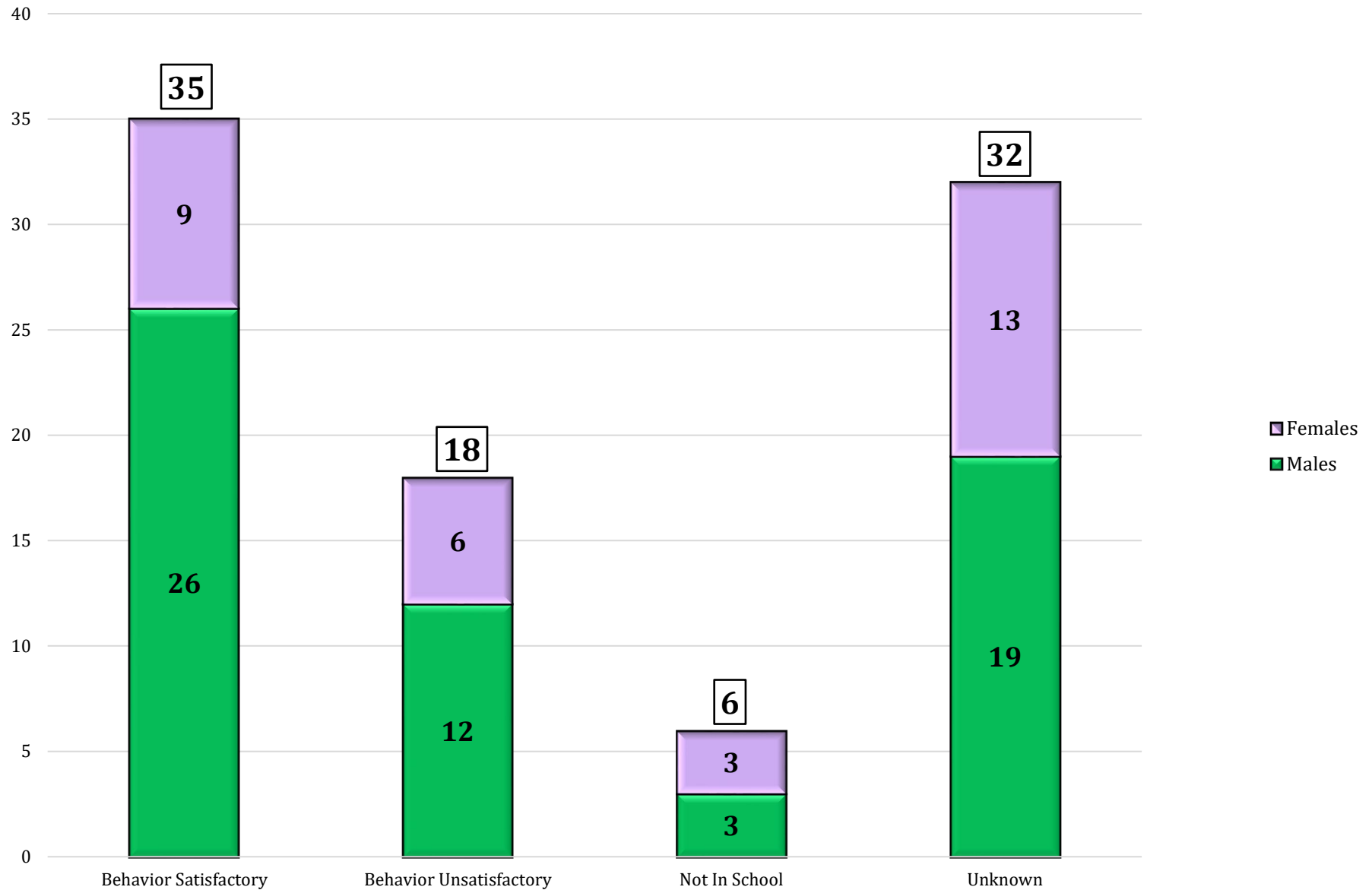

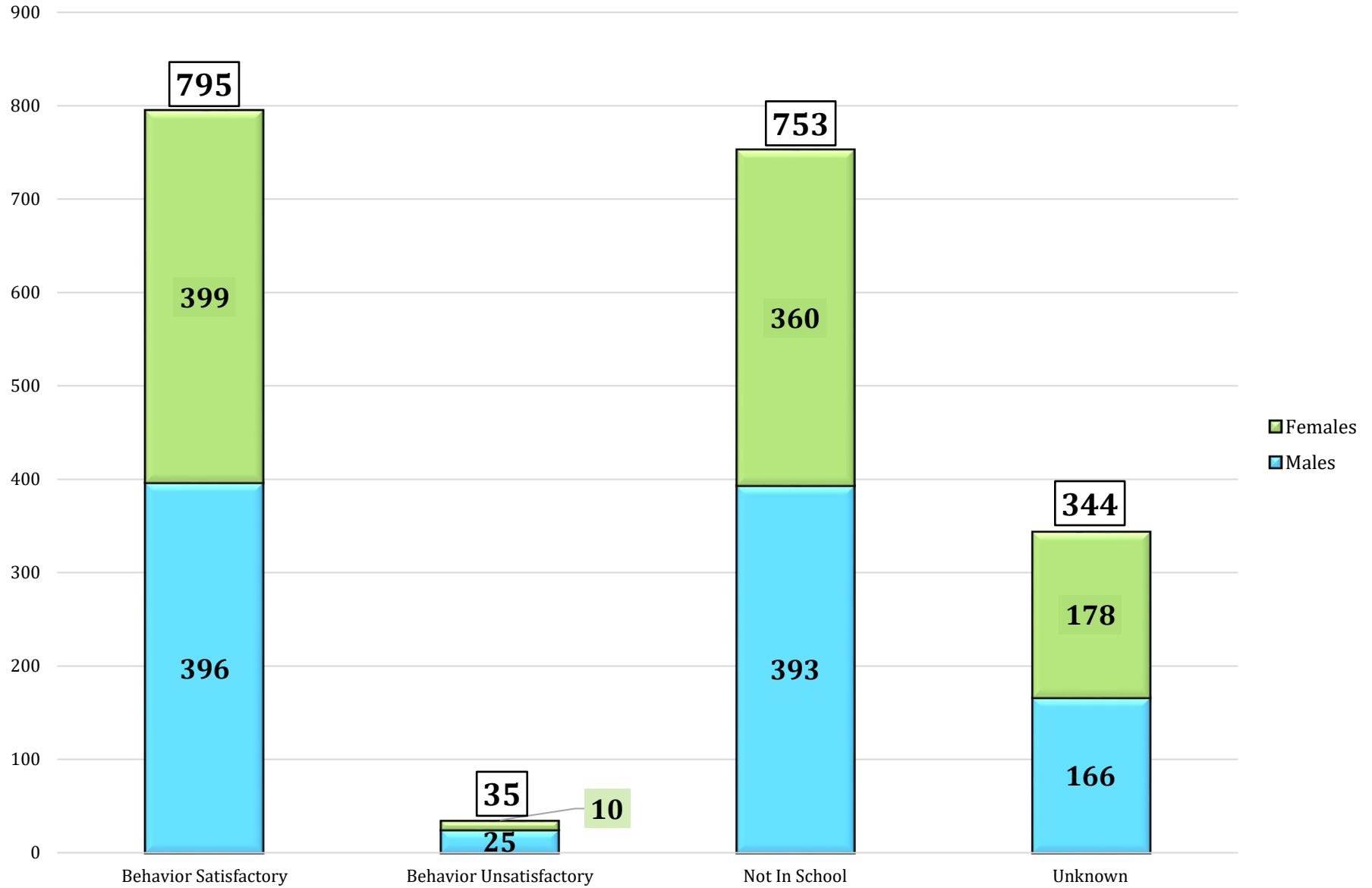

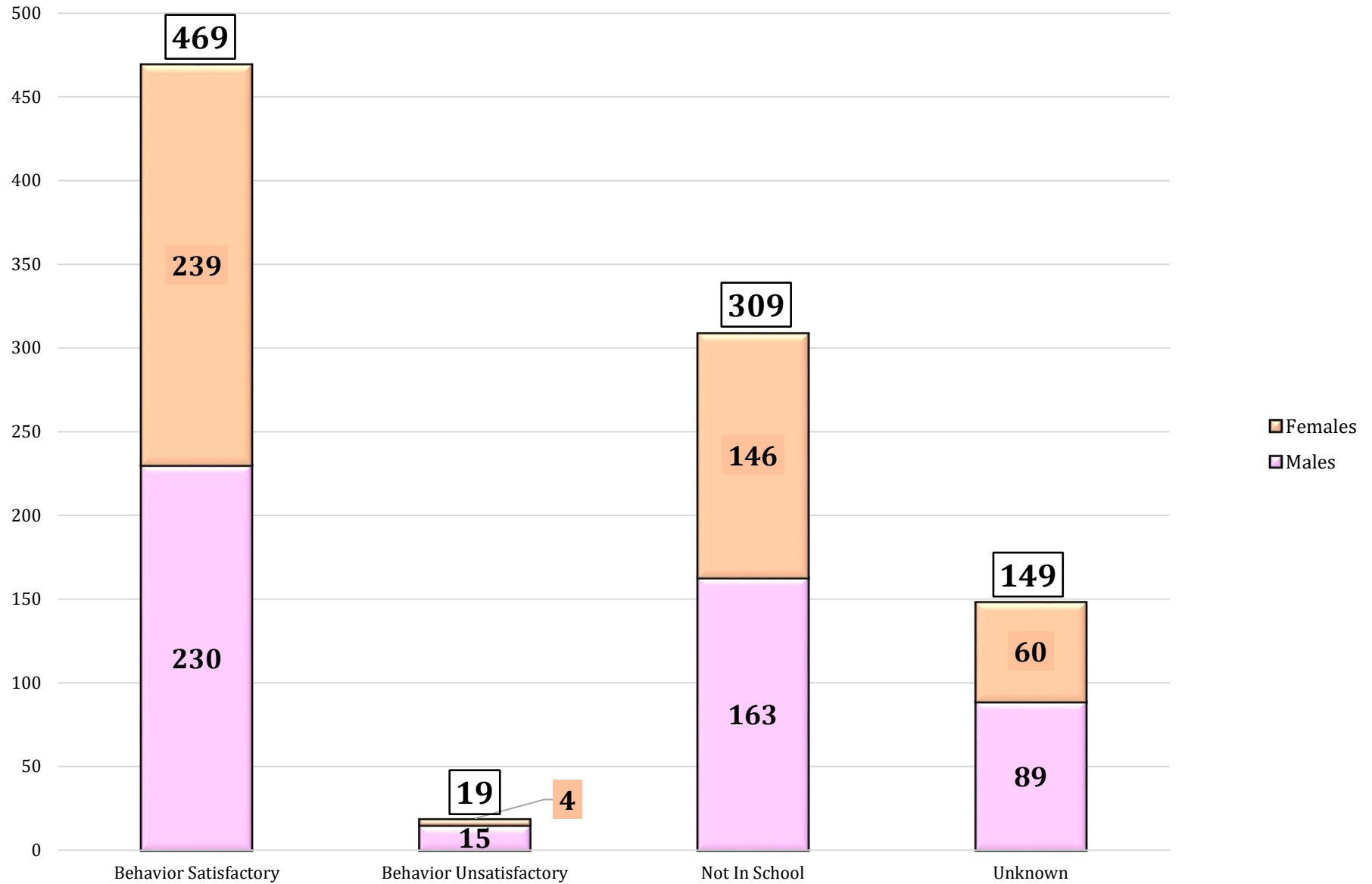

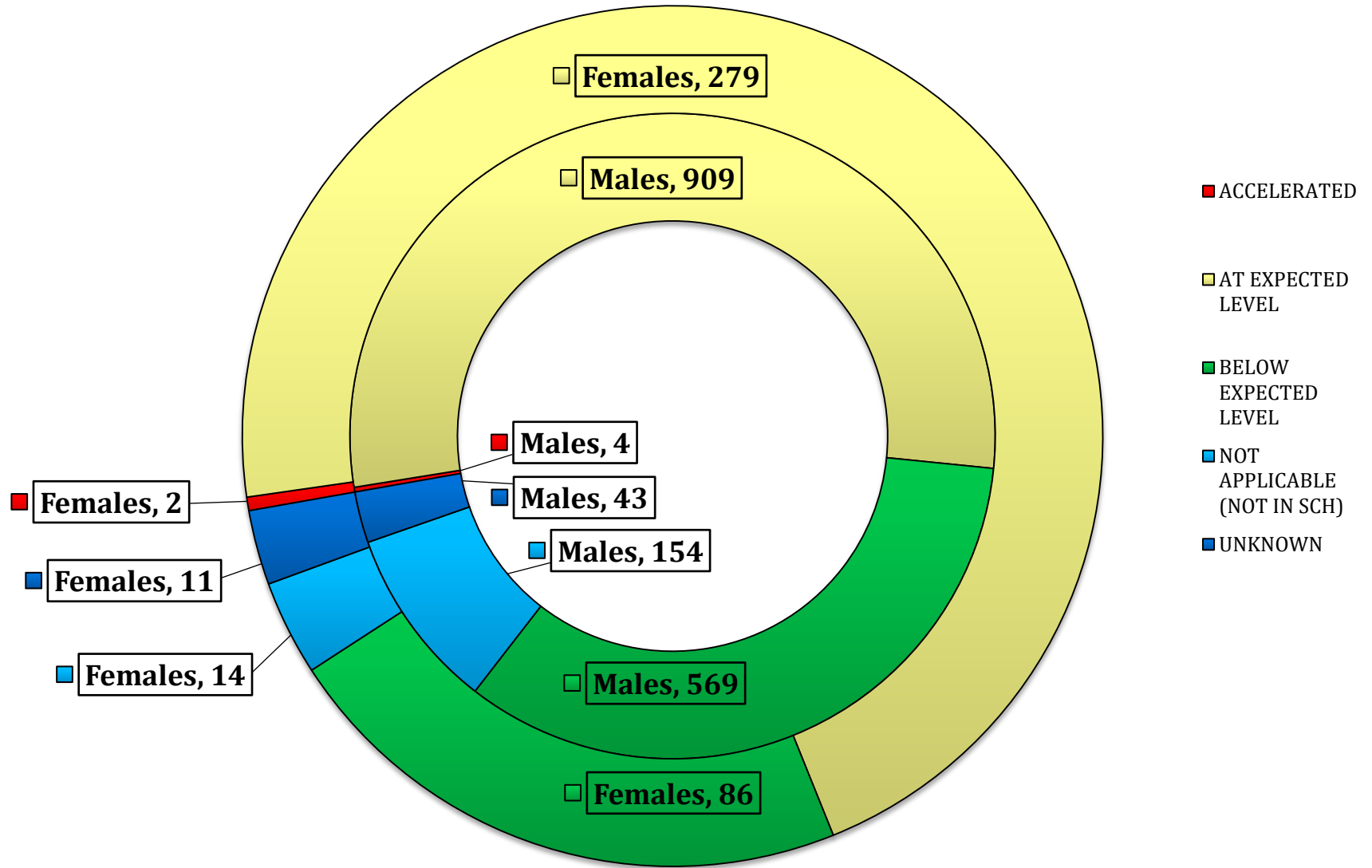

# Grade Placement in Relation to Age by Complaint Type and Gender

The following graphs depict the grade placement of children referred to Juvenile Court by age, complaint type, and gender. Options for this category include “accelerated” (meaning the child is in a grade above what would be expected for their age level), “at expected level” (meaning the child is at a grade level that would be expected based on their age), “below expected level” (meaning the child is at a grade level that is below what would be expected based on their age), “not applicable” (meaning the child is not in school), and “unknown” (meaning the grade level of the child is not known).

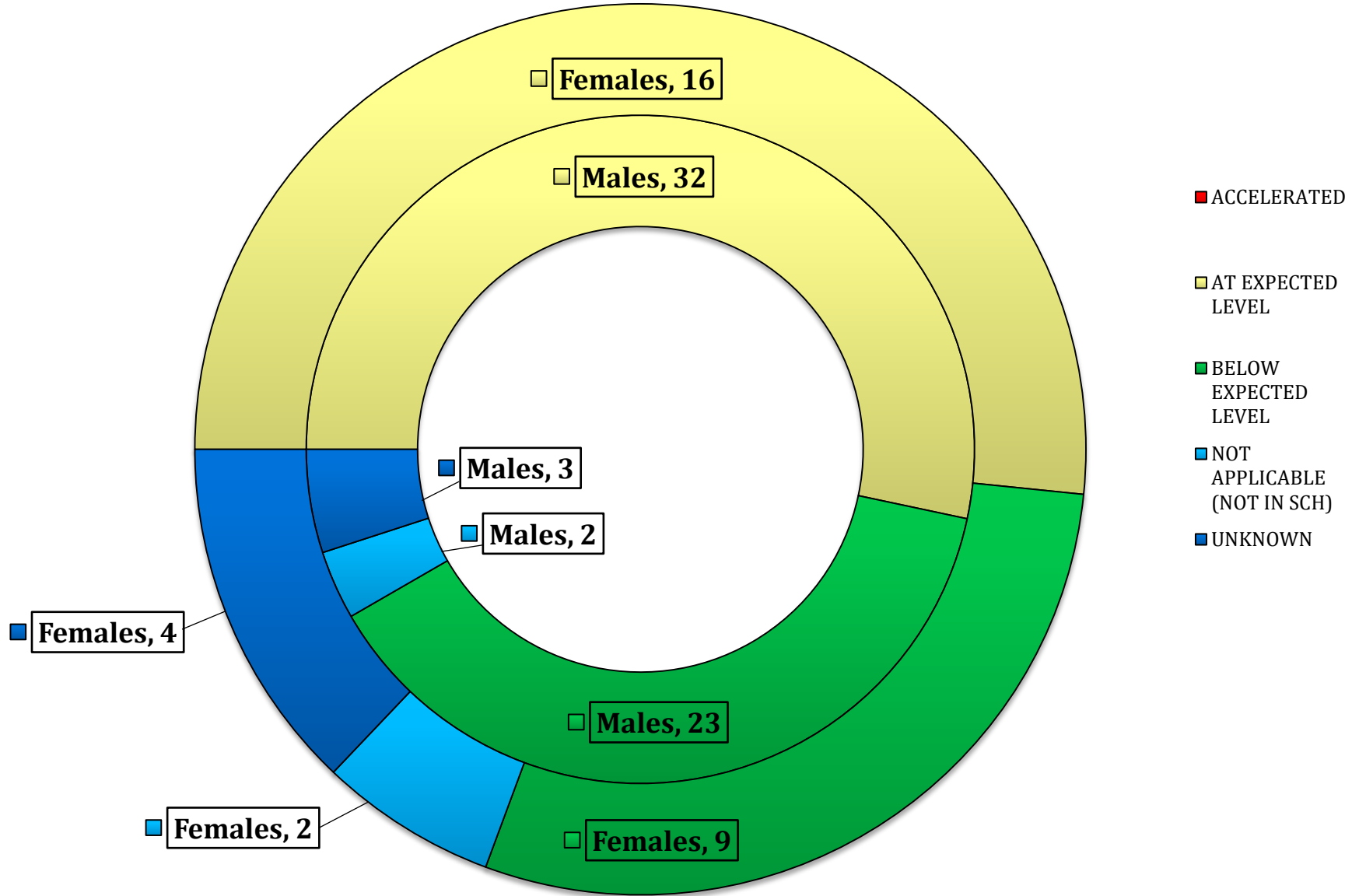

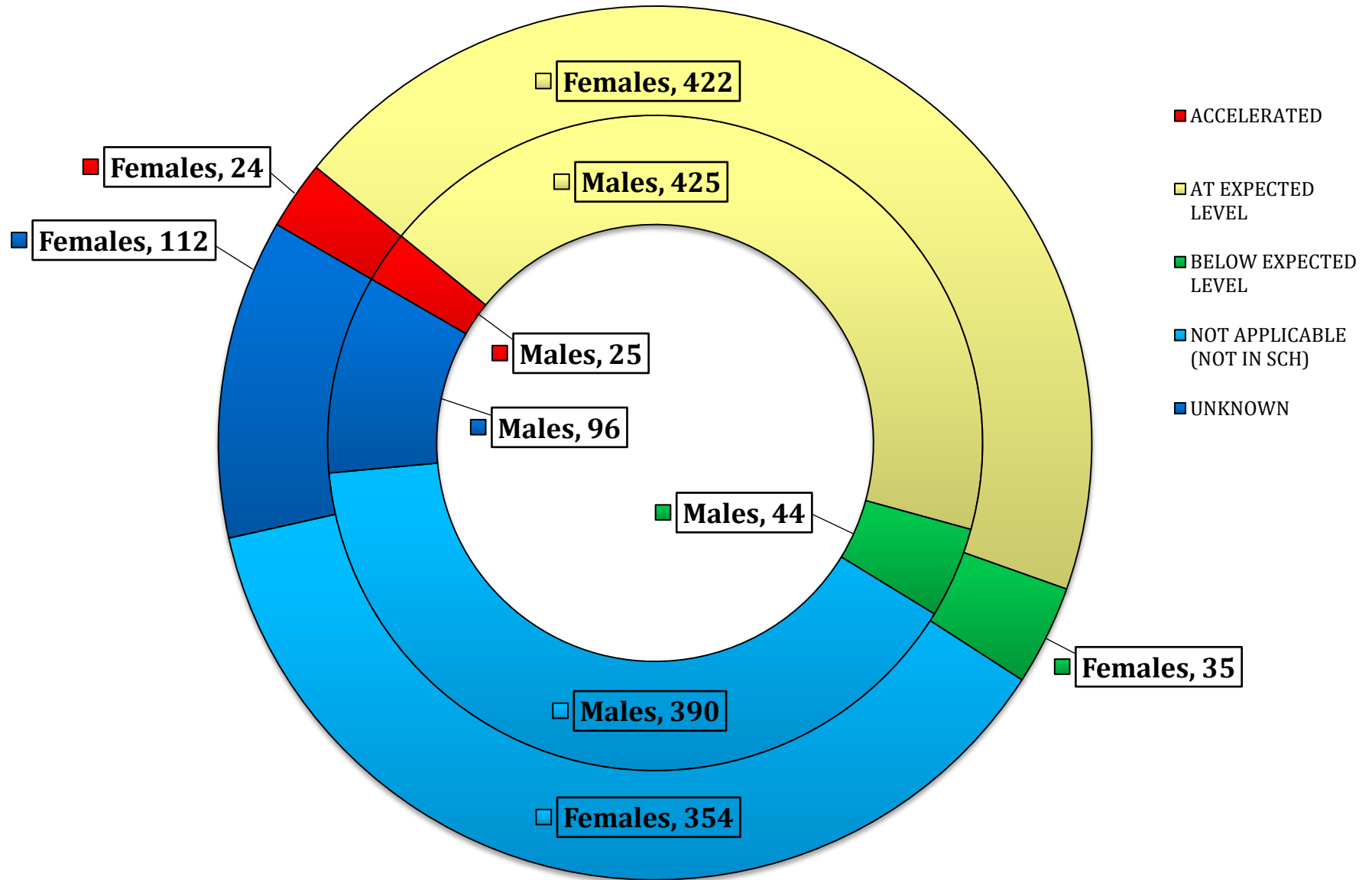

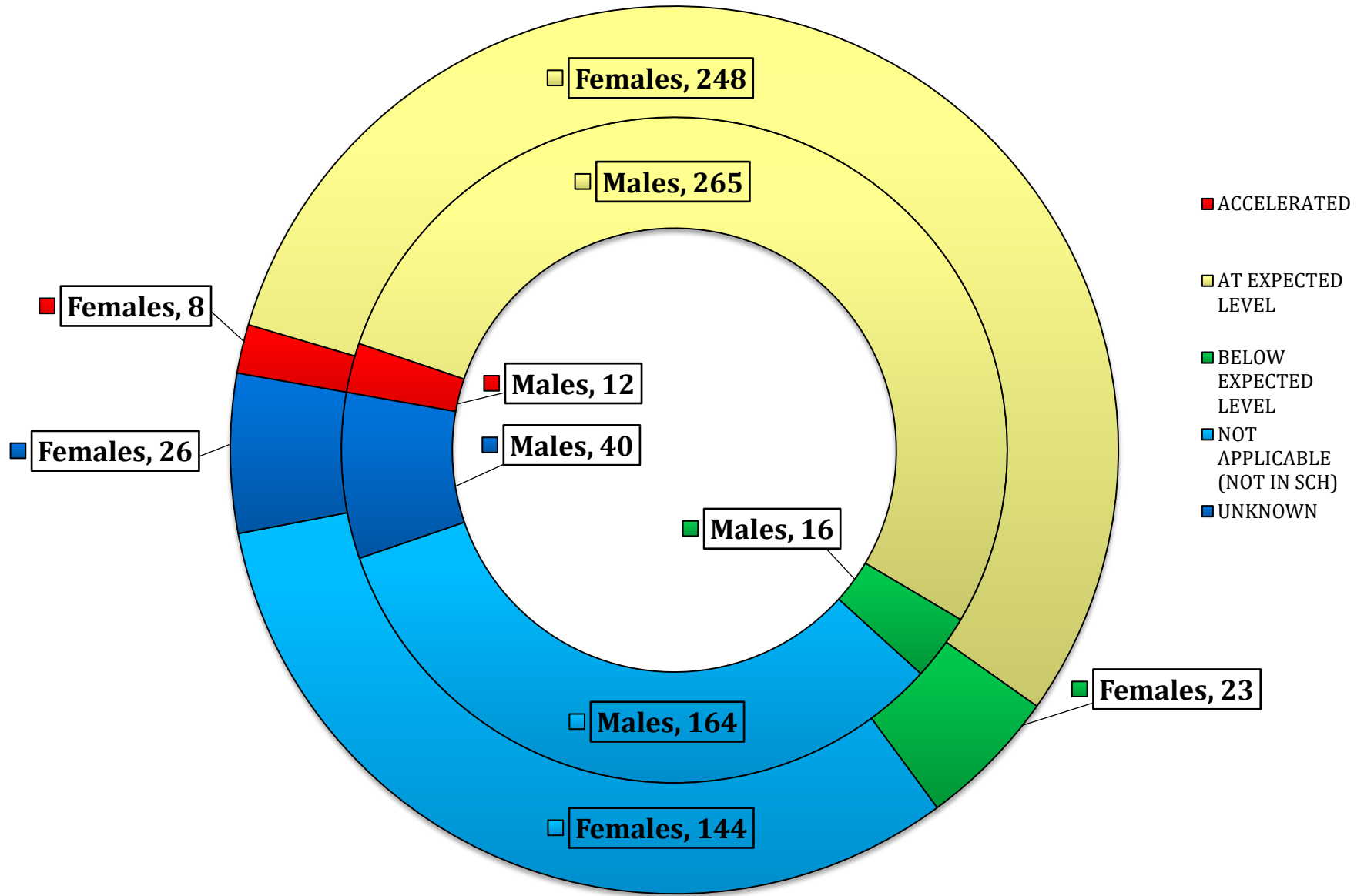
