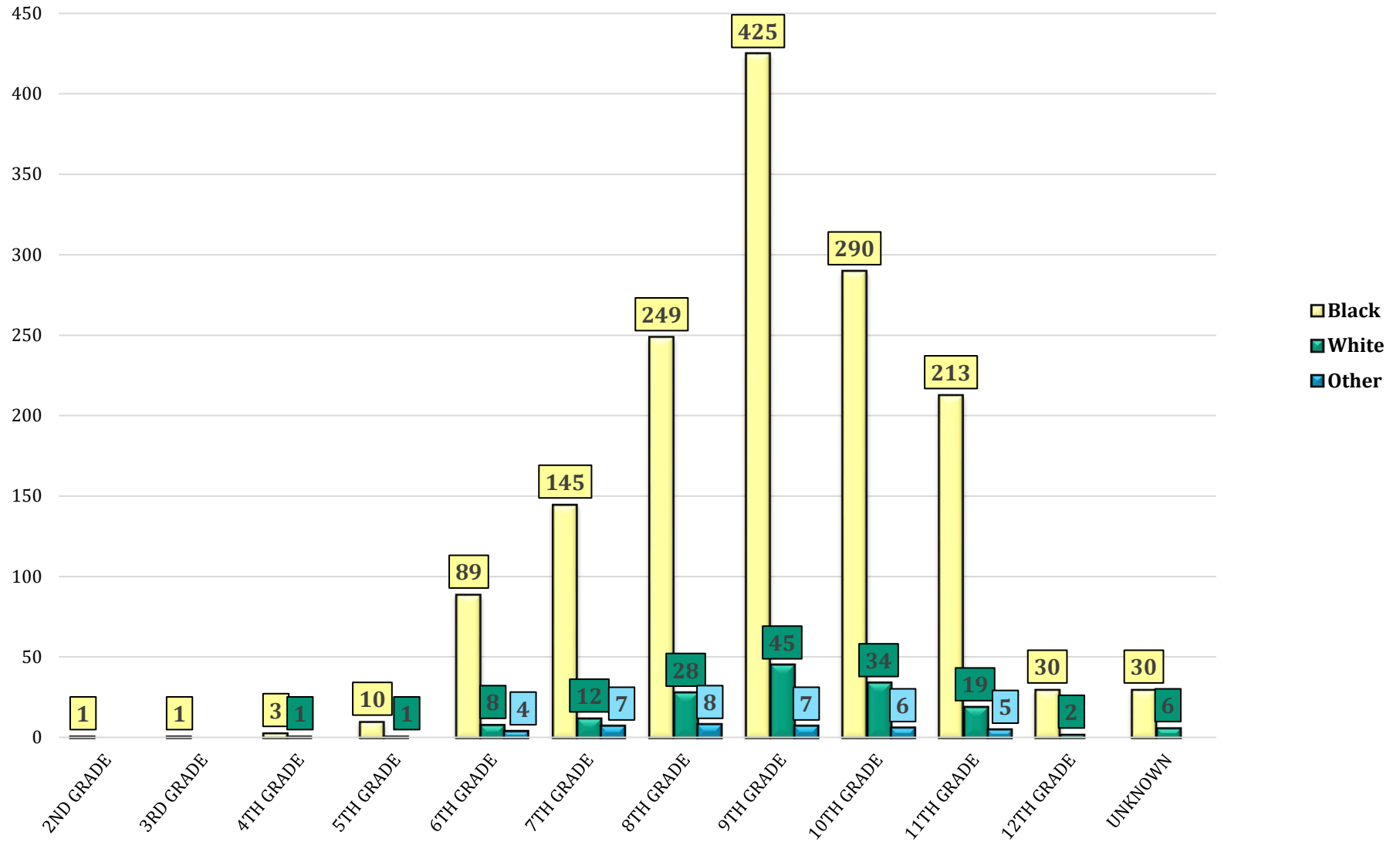


# 2021 Last Grade Completed by Race, Gender, and Complaint Type

These charts show the last grade completed of the children referred to Juvenile Court by race, gender, and complaint type.

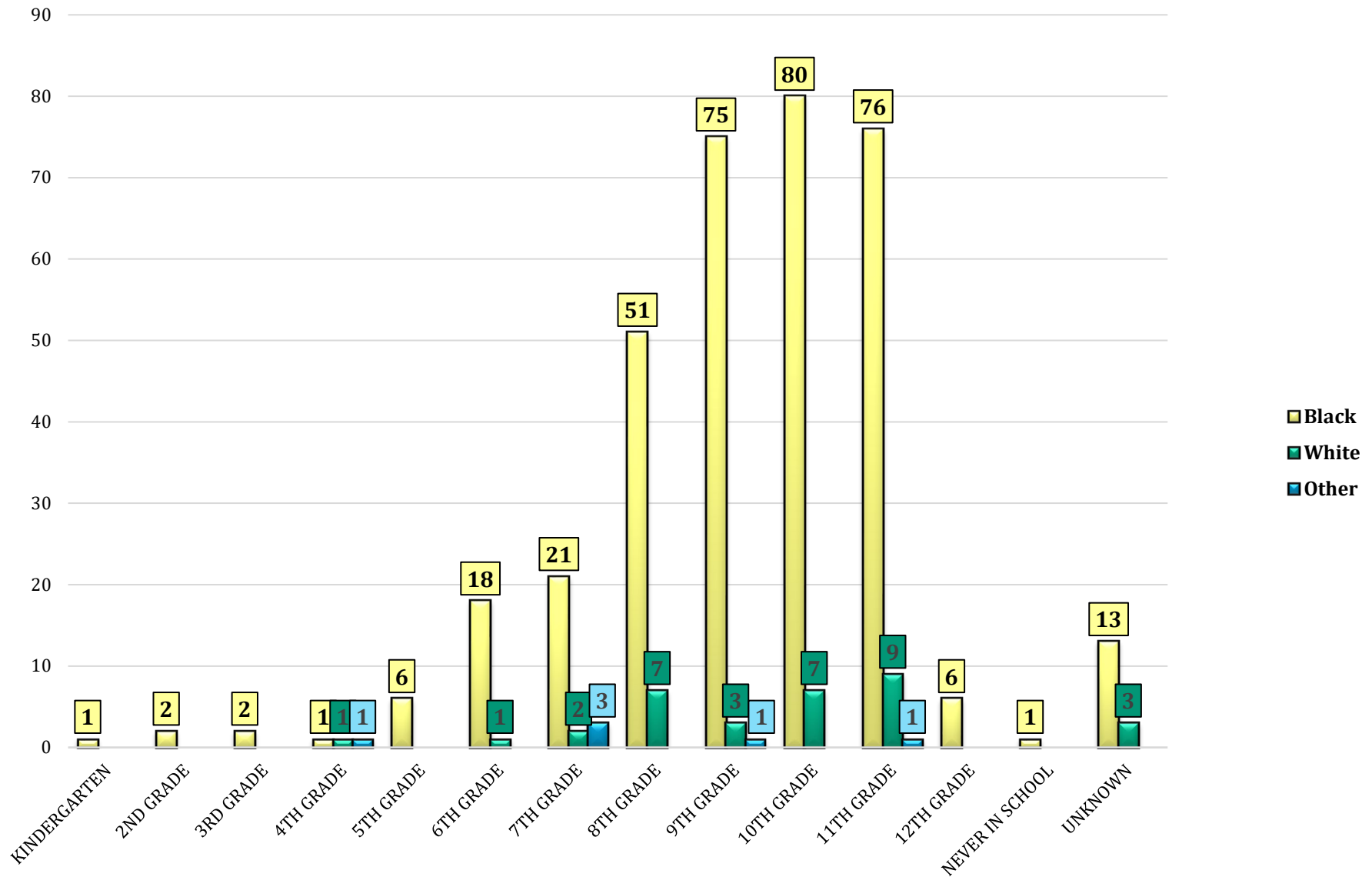

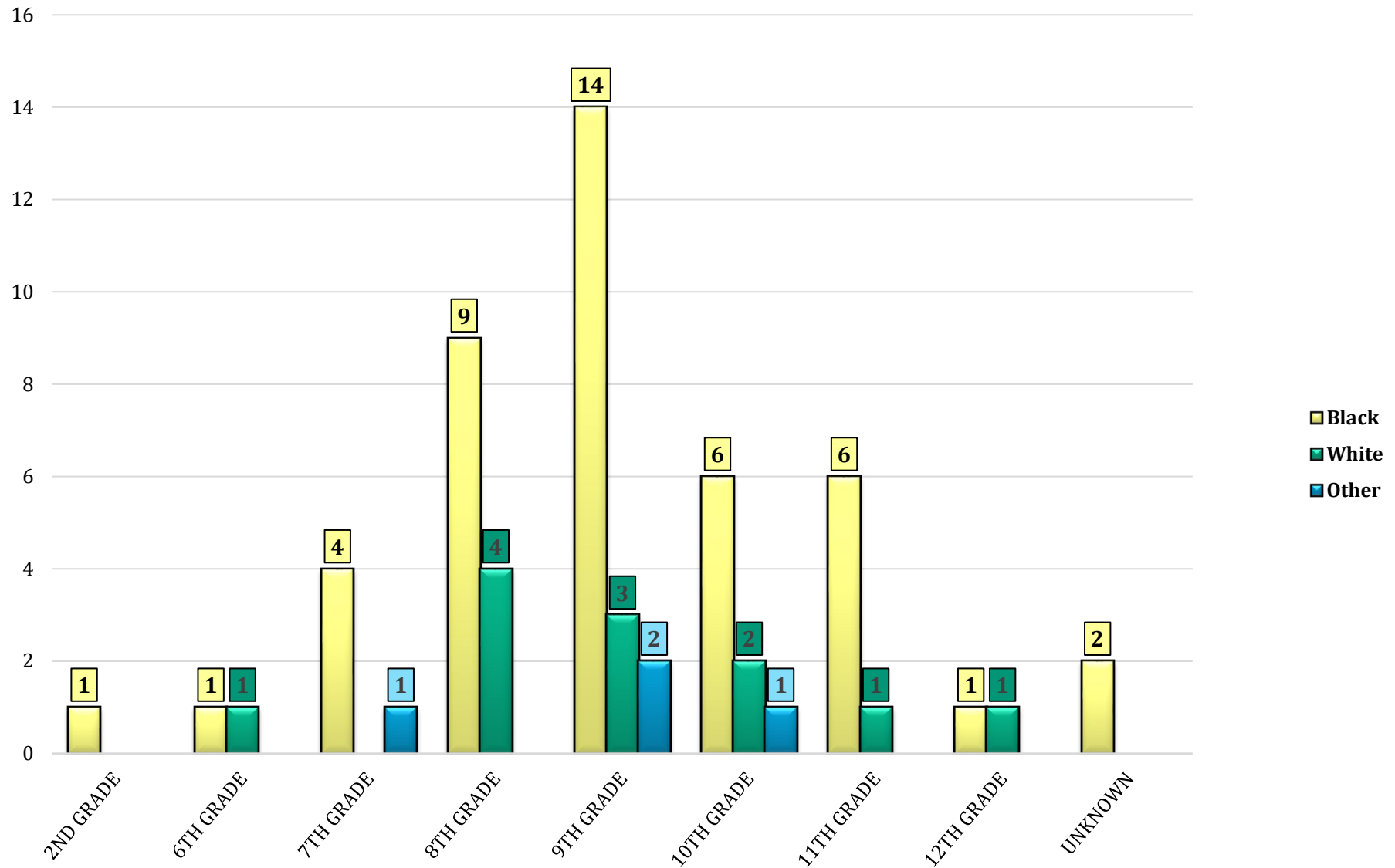

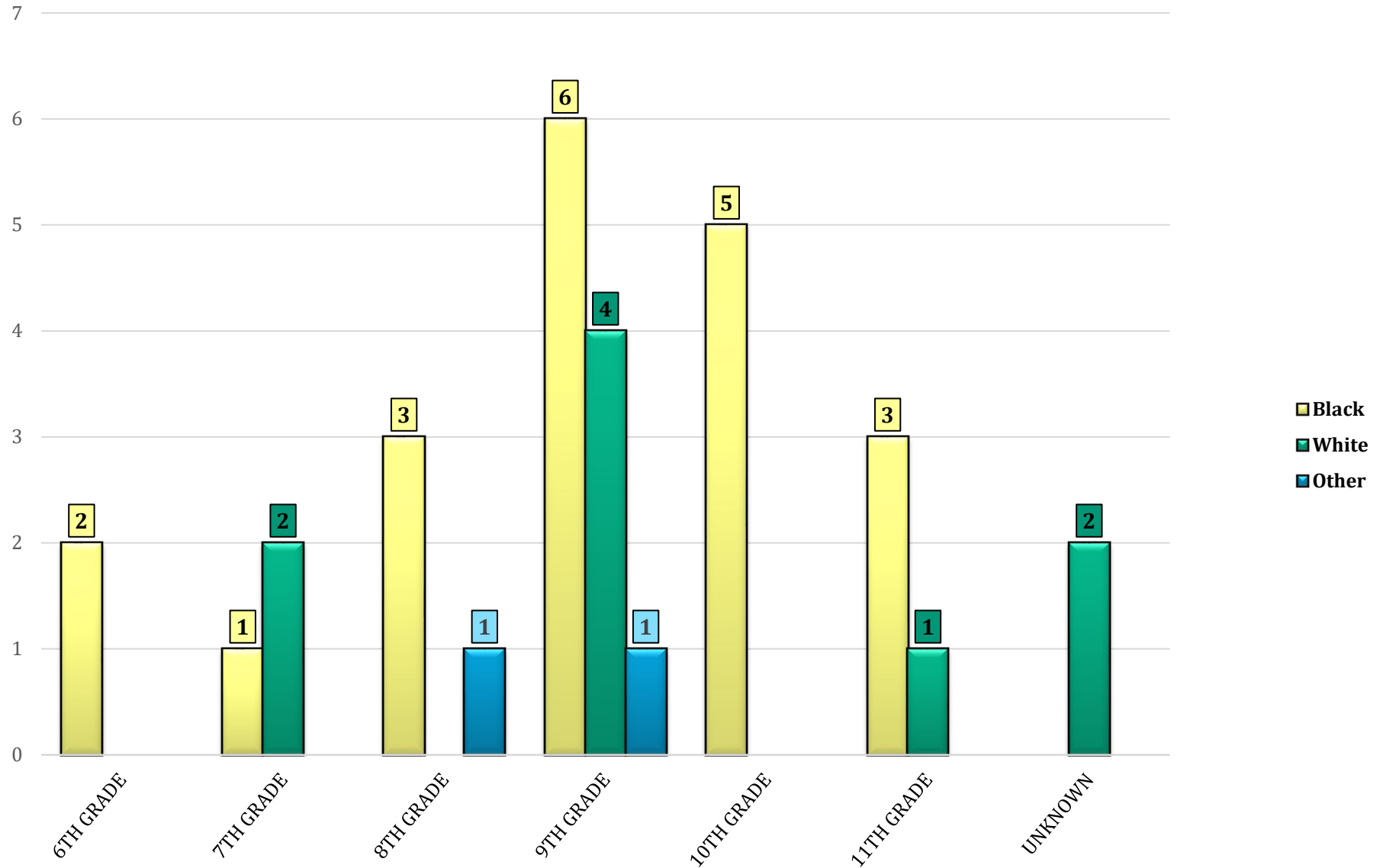

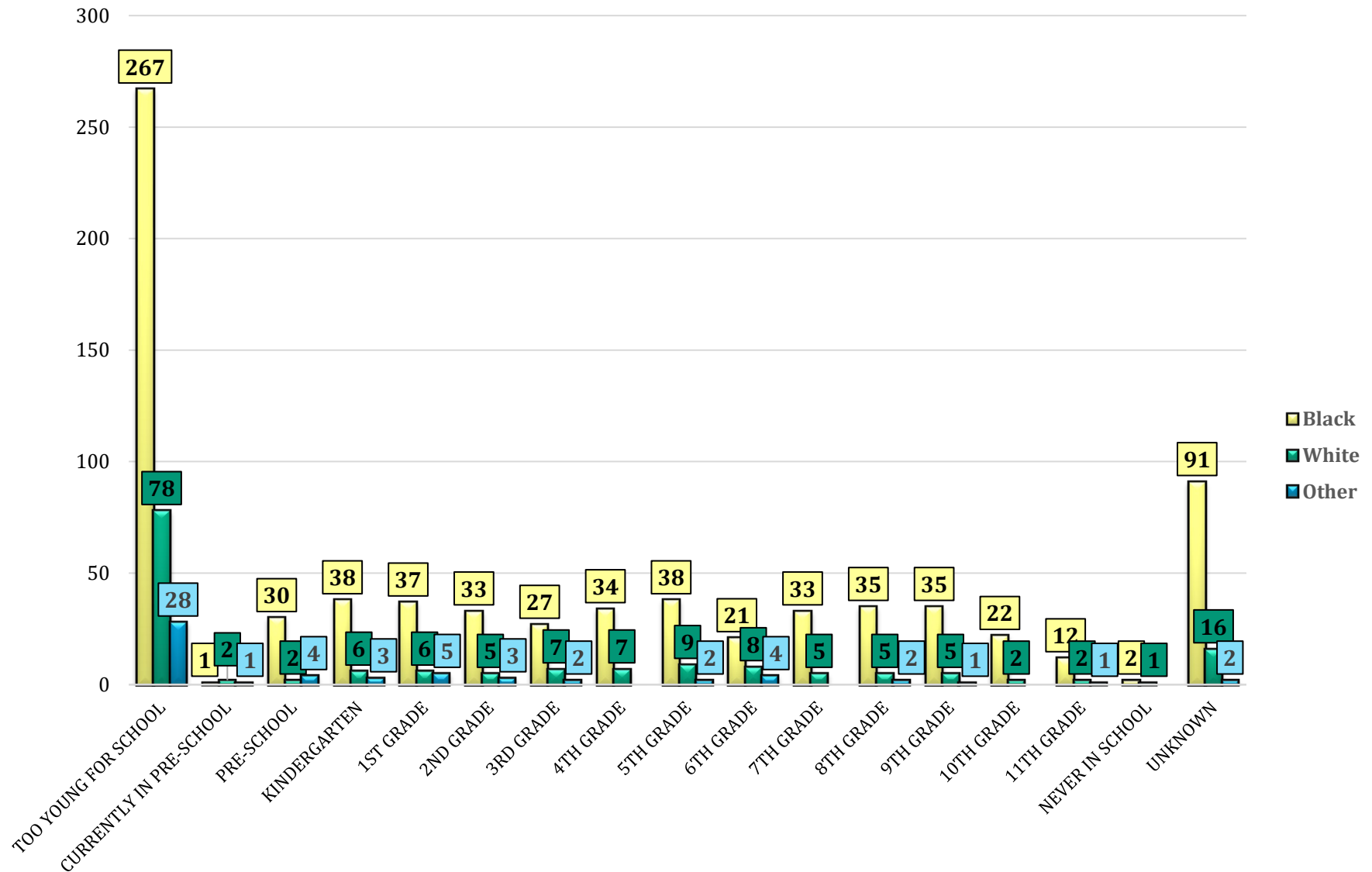

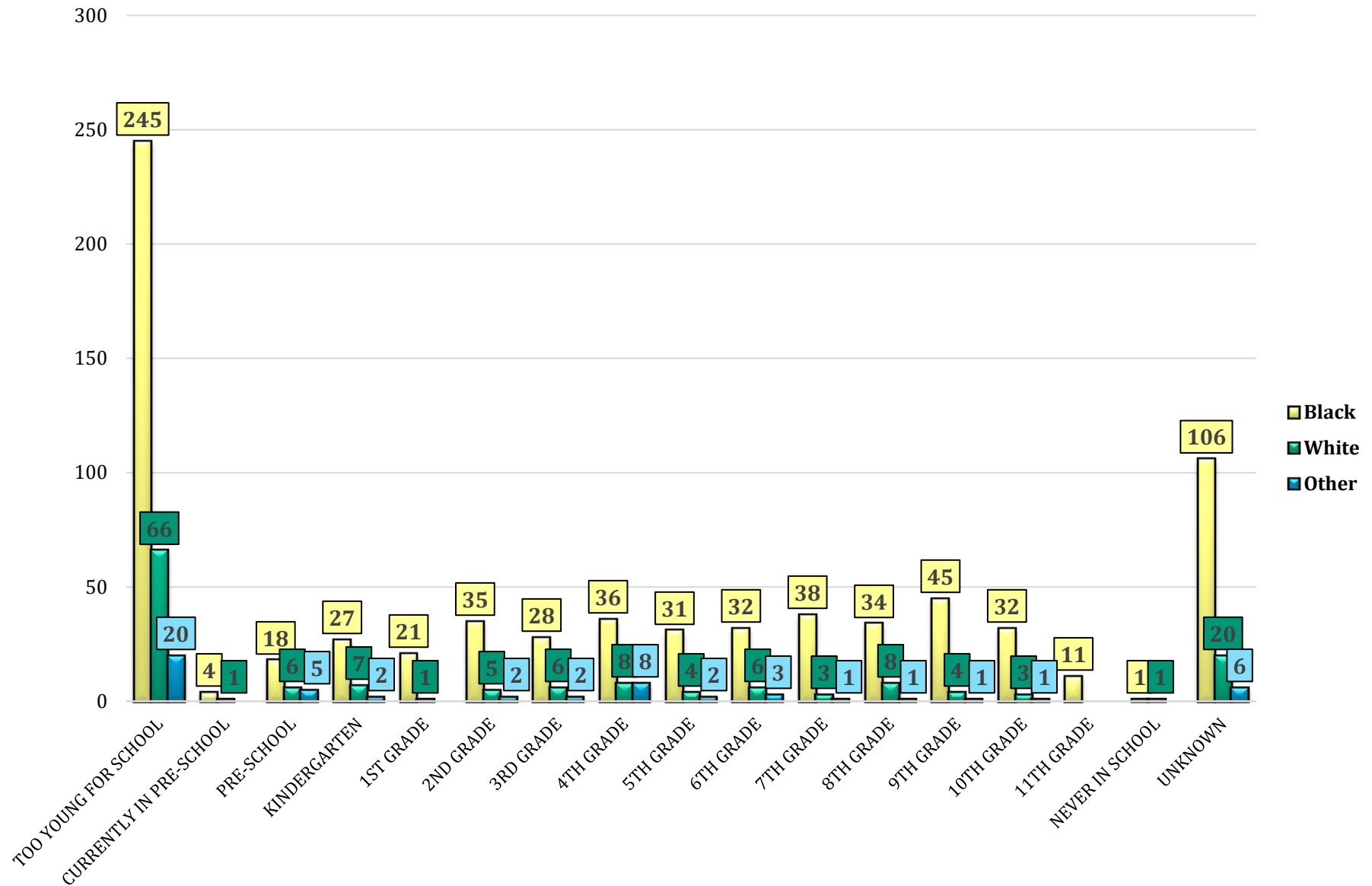

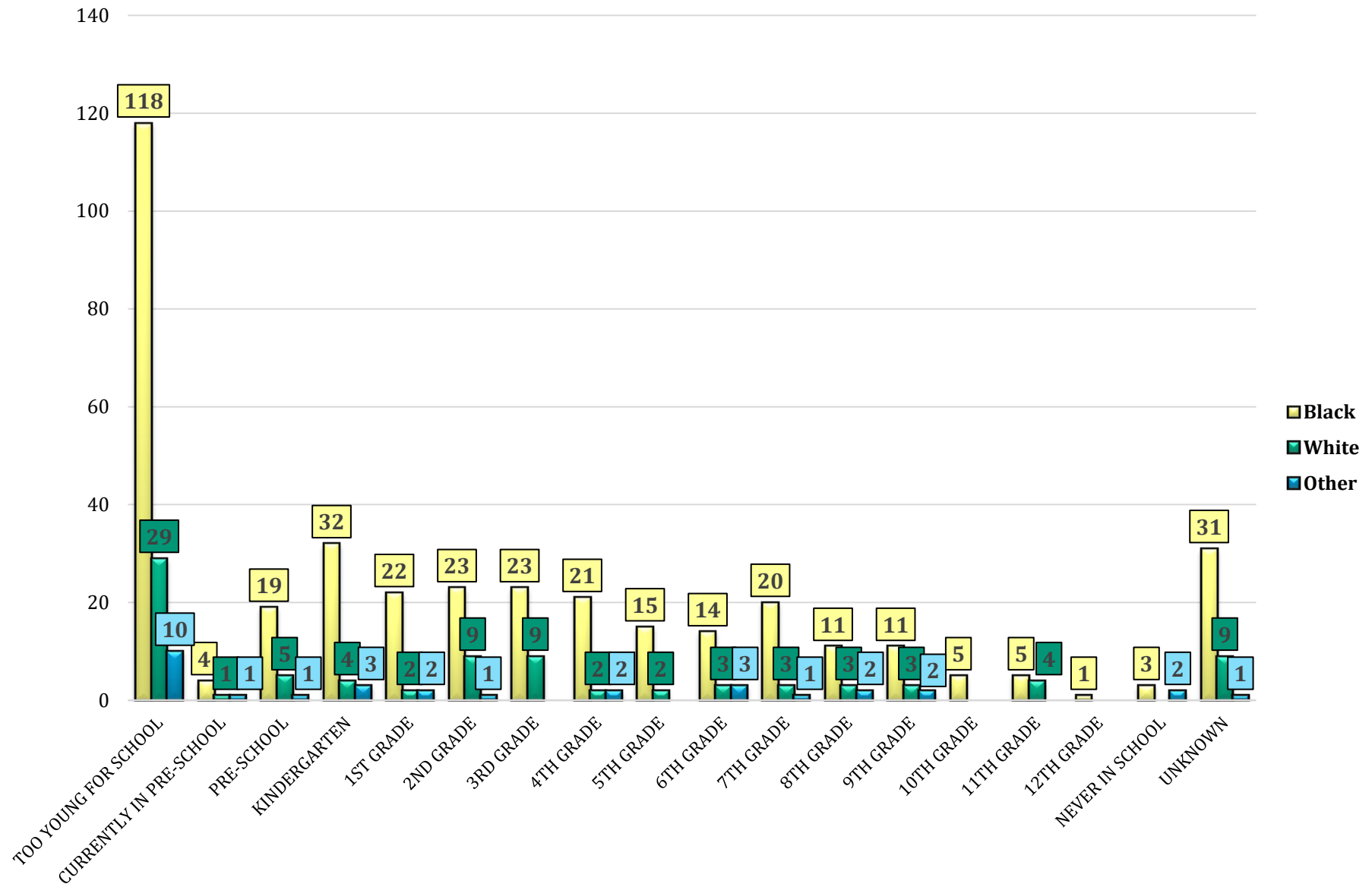

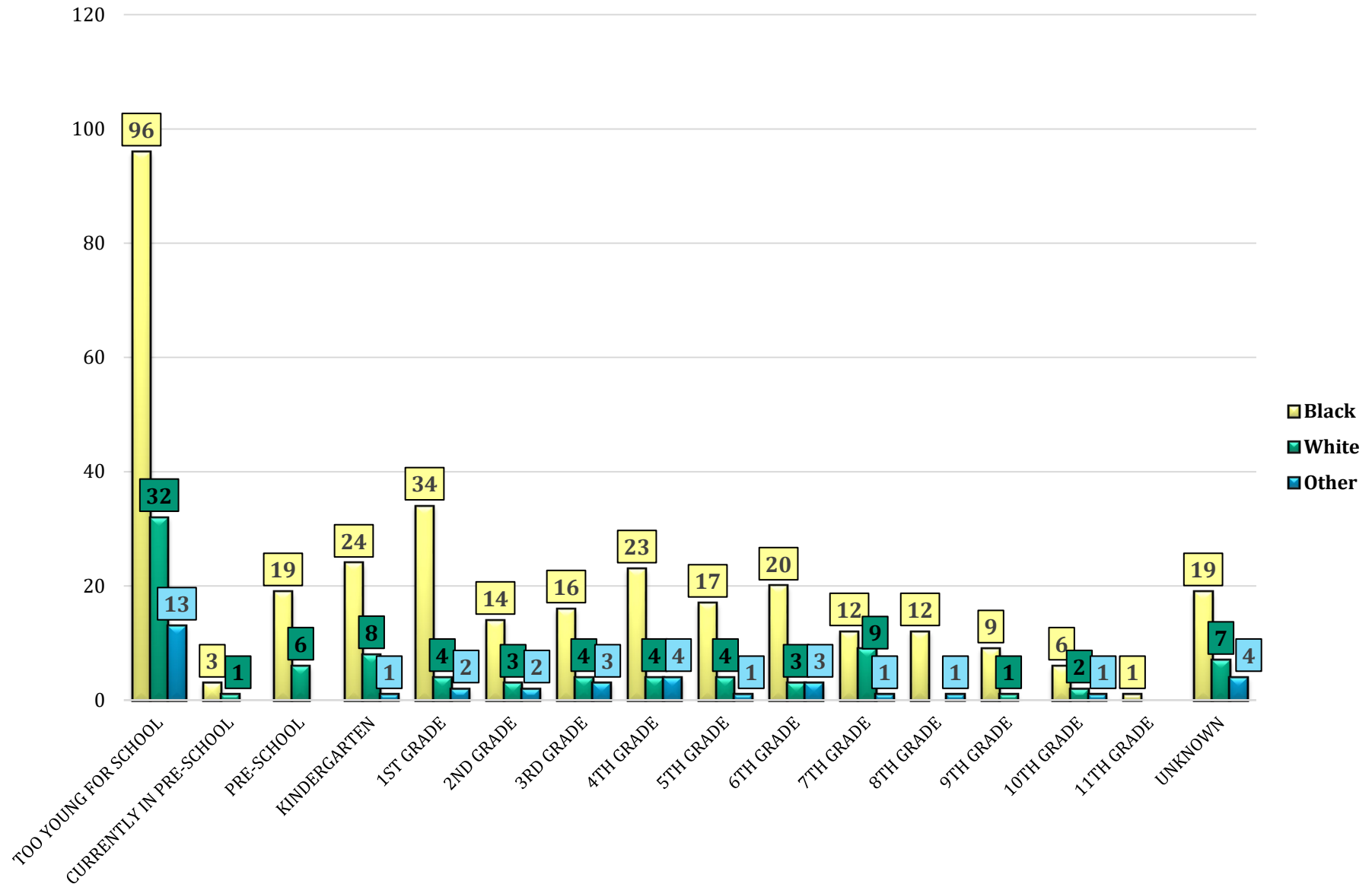



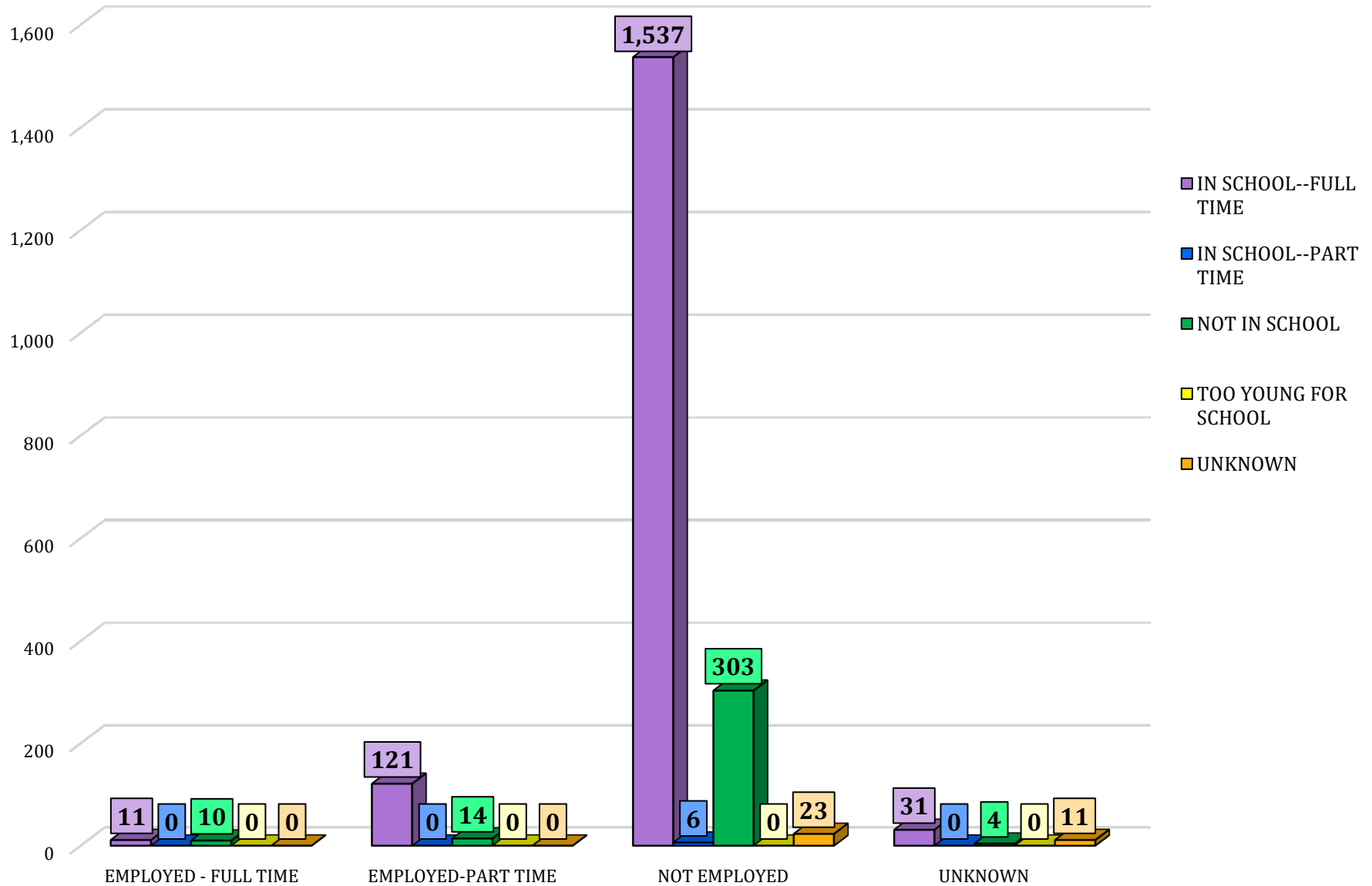

# 2021 Employment and School Status of Children Referred to Juvenile Court by Type of Complaint

These graphs depict both the employment and school status of the children referred to Juvenile Court by the type of complaint. Employment status refers to whether the child has a job. If so, is the child employed full or part-time. School status refers to whether the child is enrolled in school. If so, does that child attend school full- or part-time.

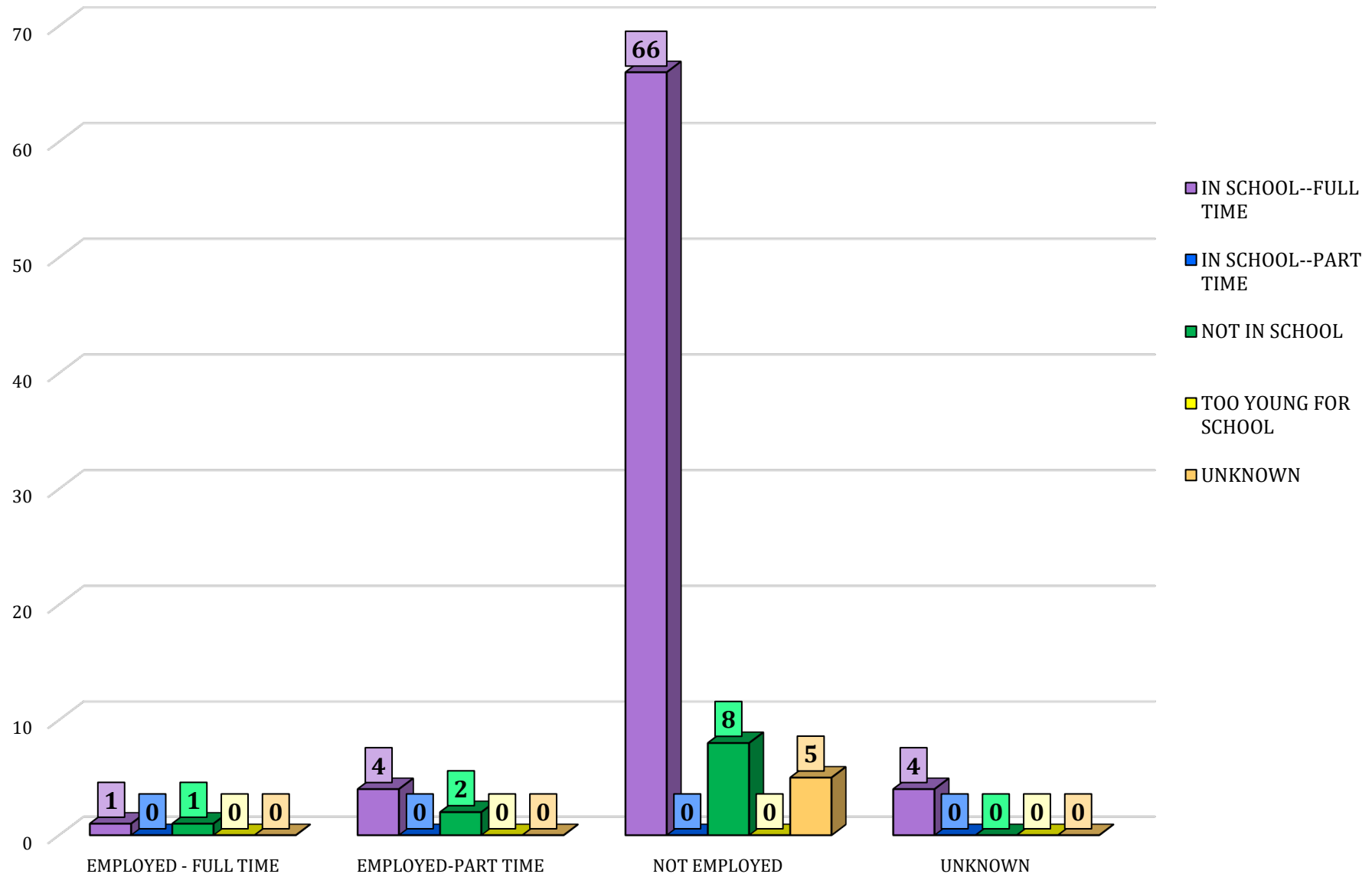

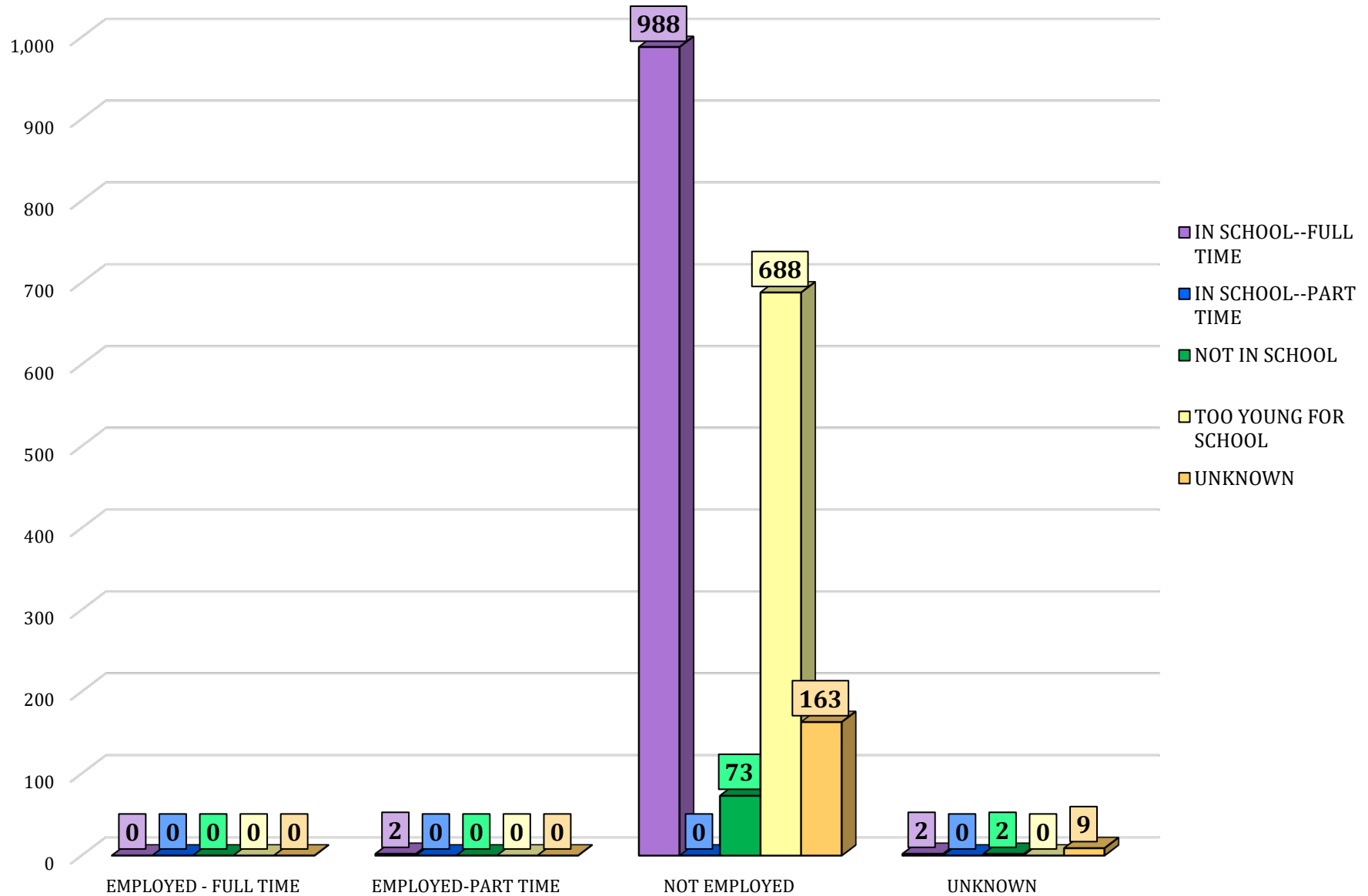

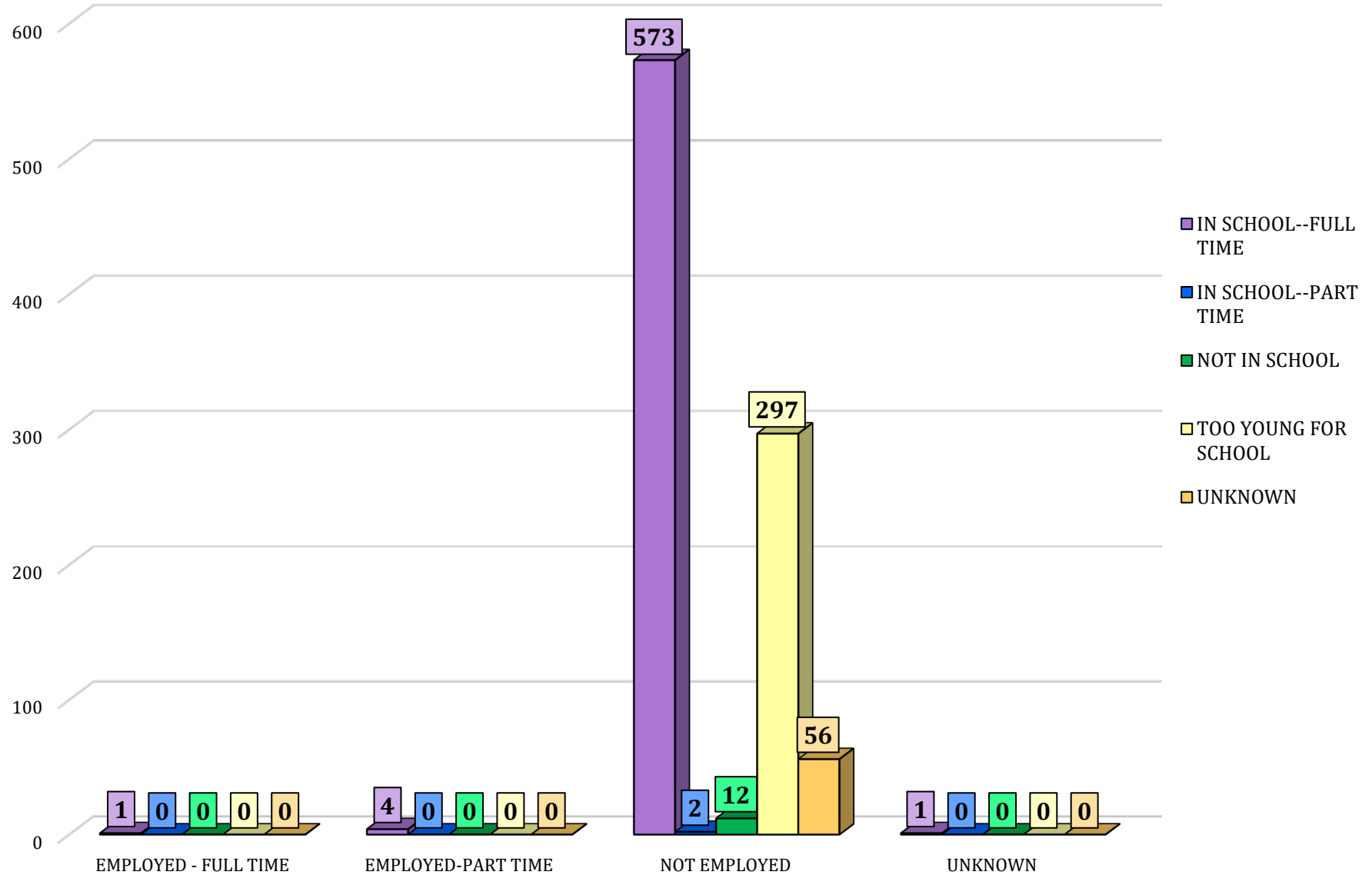



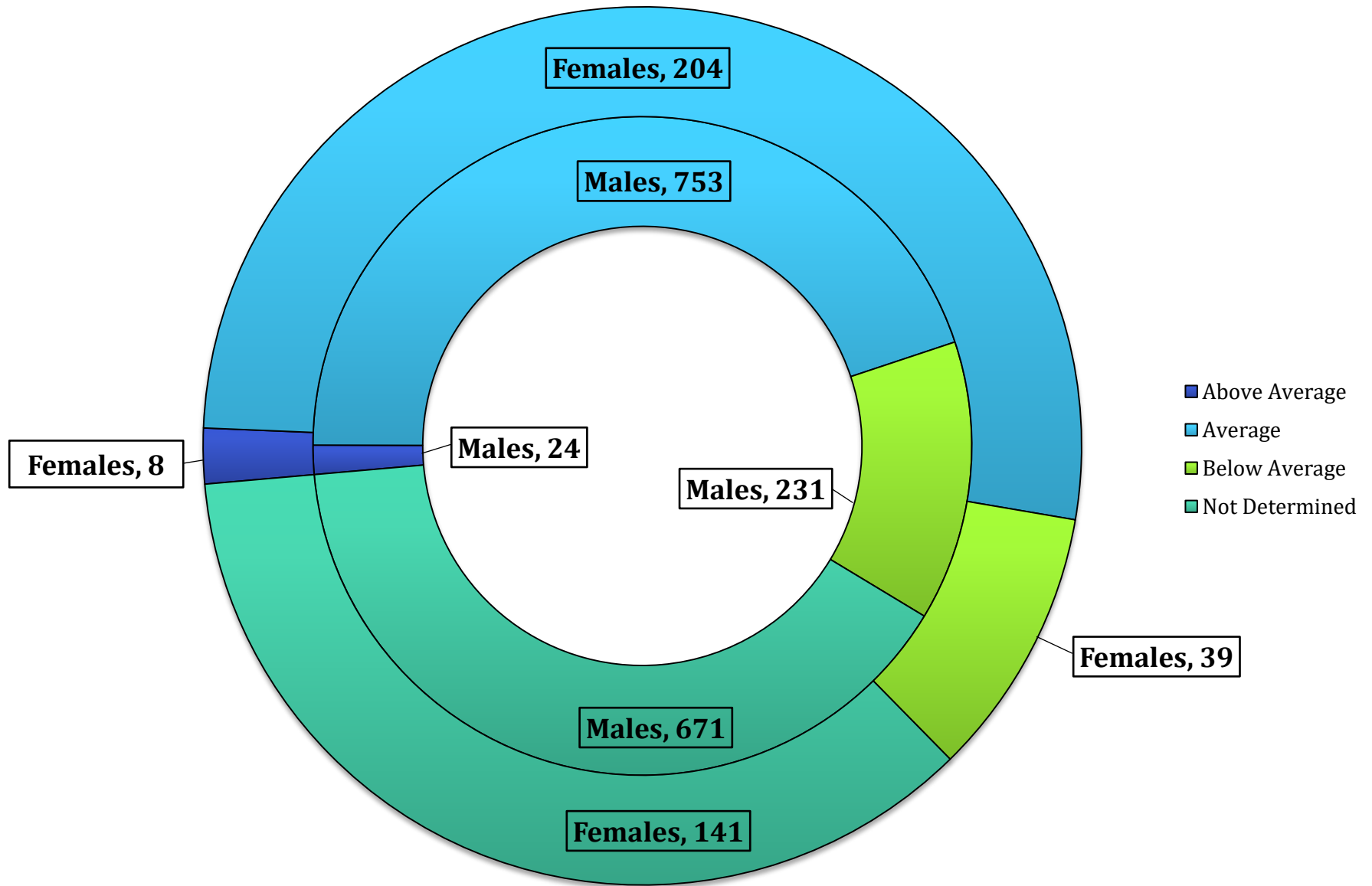

# 2021 Estimated Mental Capacity by Gender and Type of Complaint



These graphs show the estimated mental capacity of the children referred to Juvenile Court by gender and type of complaint. Estimated mental capacity options include “above average”, which indicates that the child has above average intelligence and is possibly enrolled in school in a grade higher than would be expected based upon age; “average”, which indicates that the child has average intelligence and is probably enrolled in school in a grade that would be expected based upon age; “below average”, which indicates that the child has below average intelligence and is probably enrolled in school at a grade that would be lower than expected based upon age; and “not determined”, which indicates that the mental capacity of the child has not been determined, usually due to the fact that the child is too young or has not been enrolled in school.

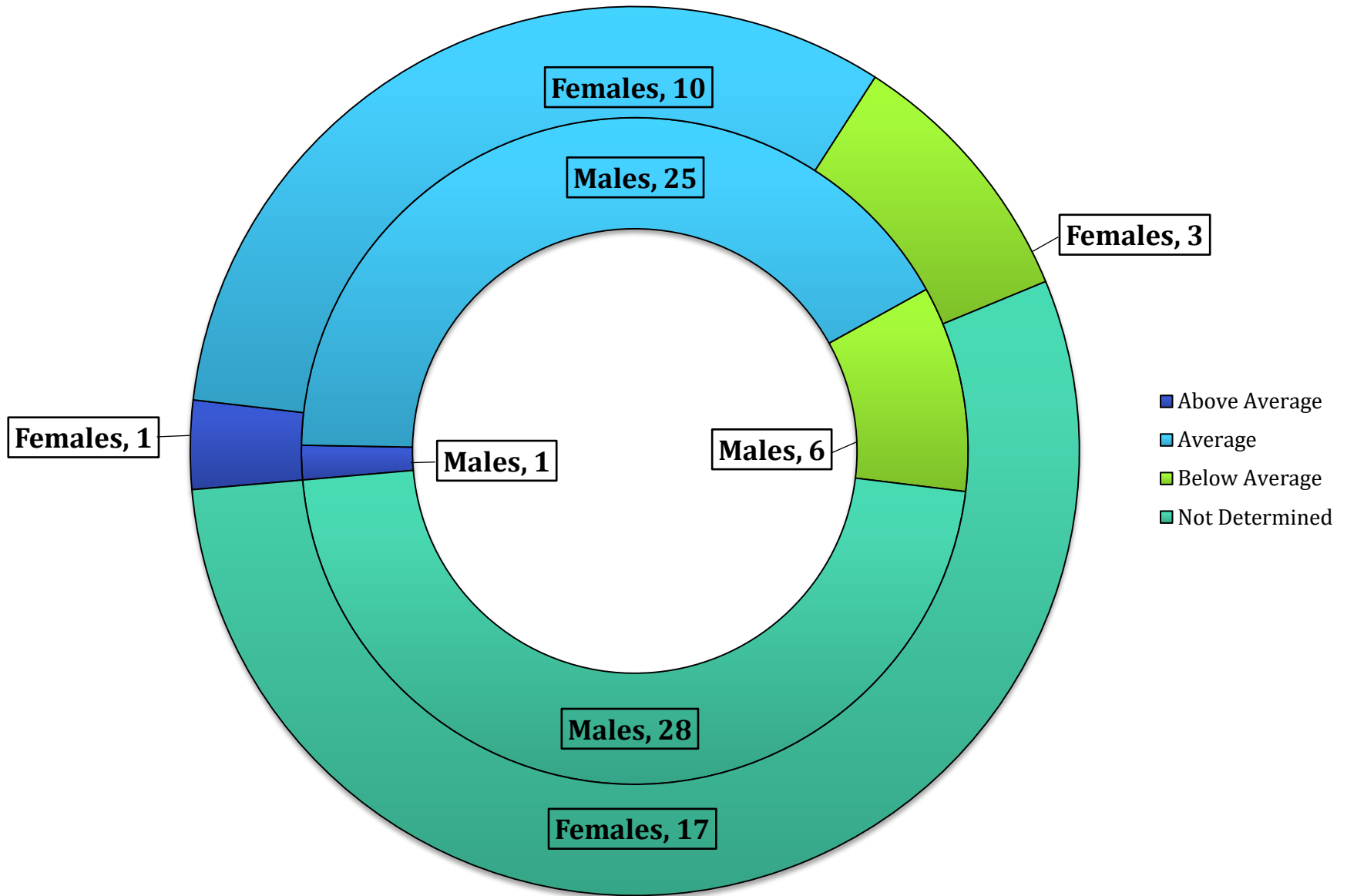

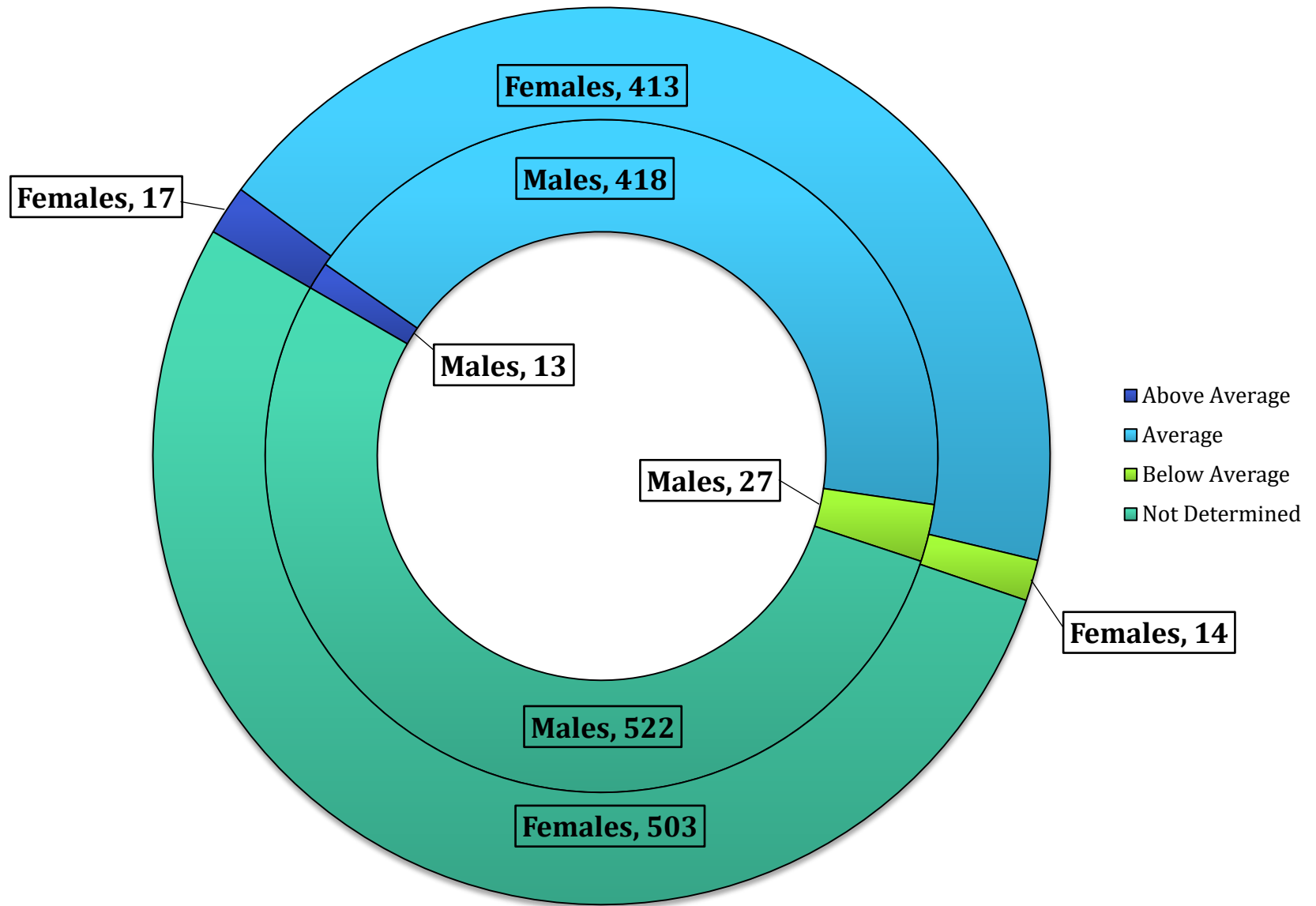

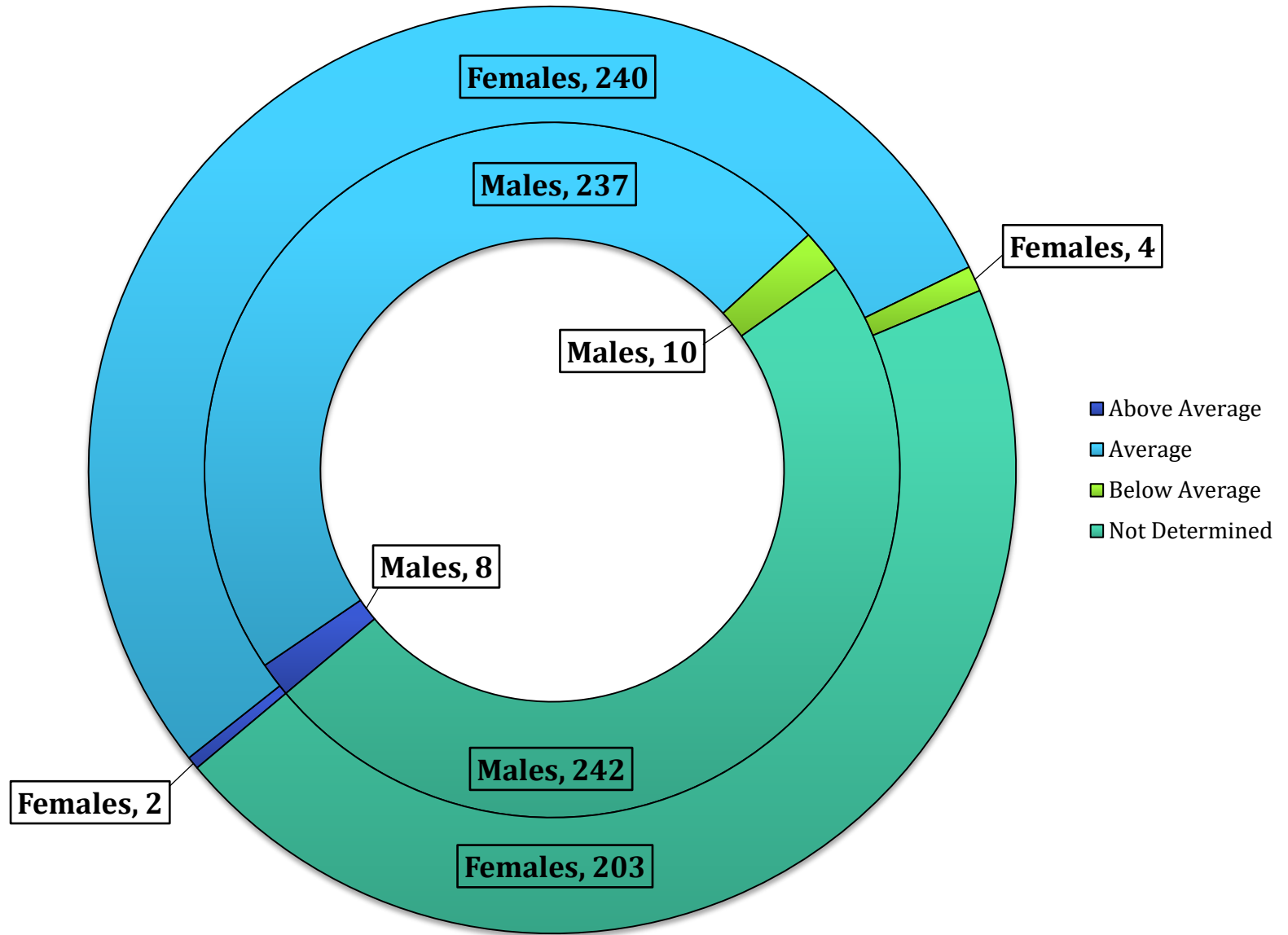

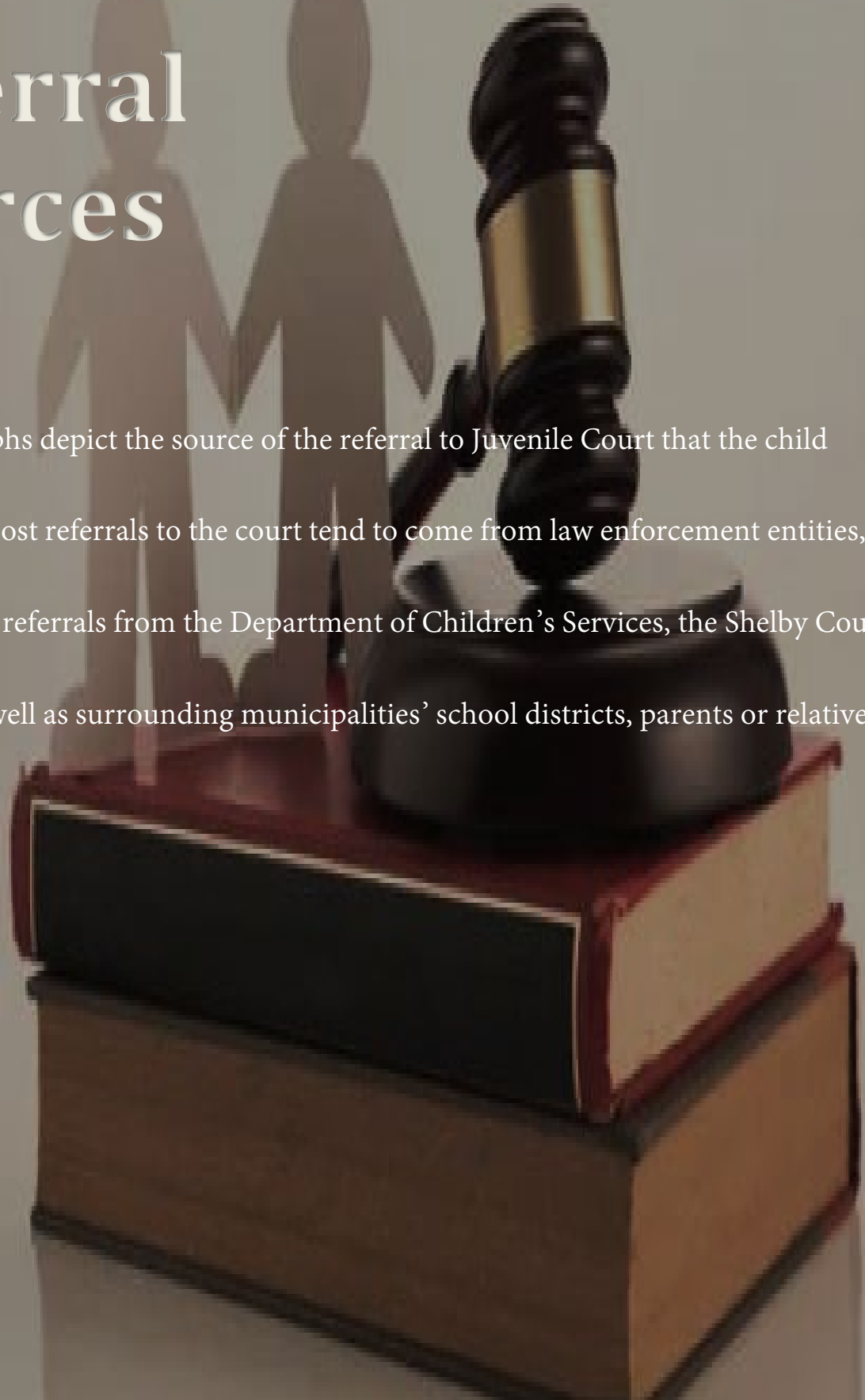

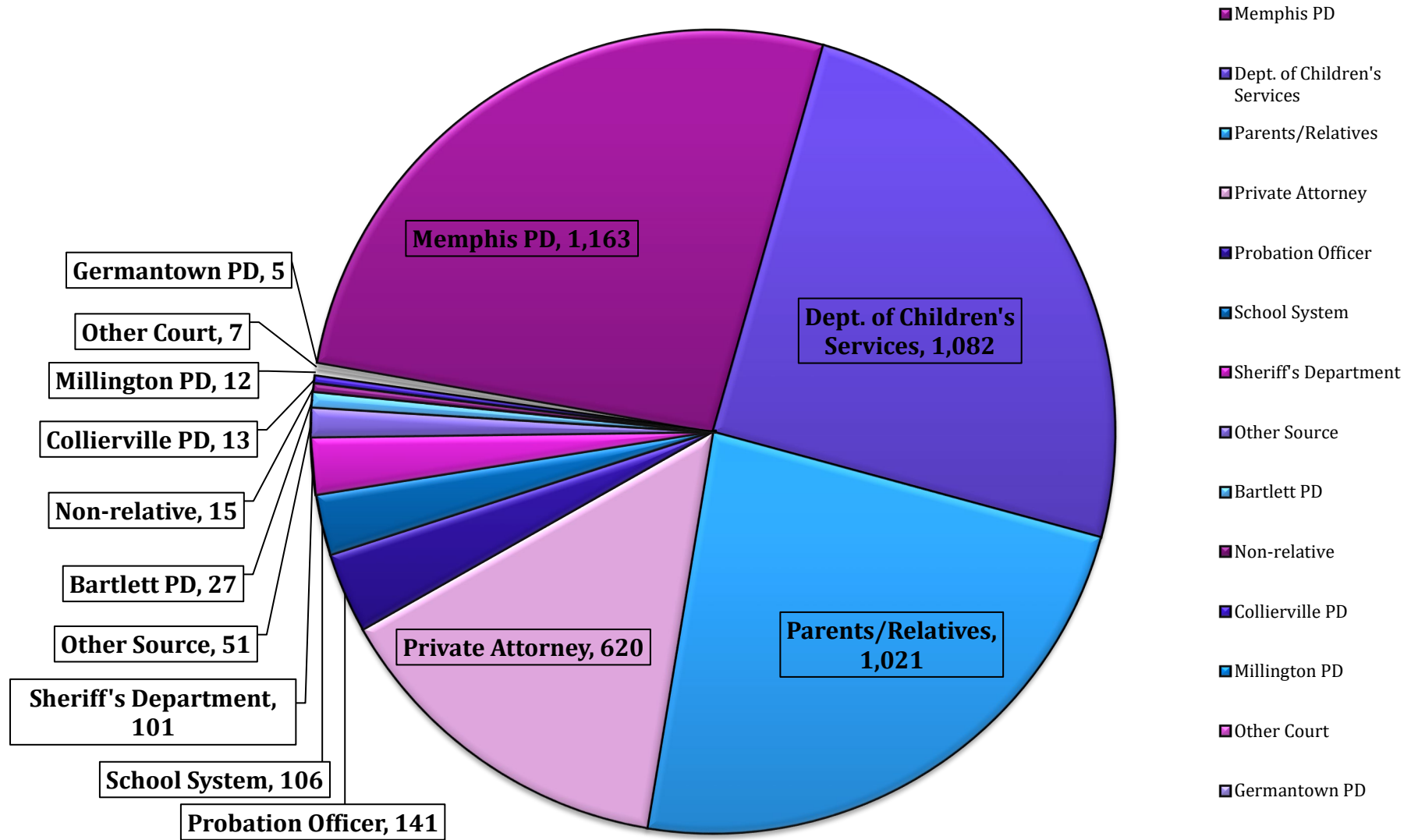

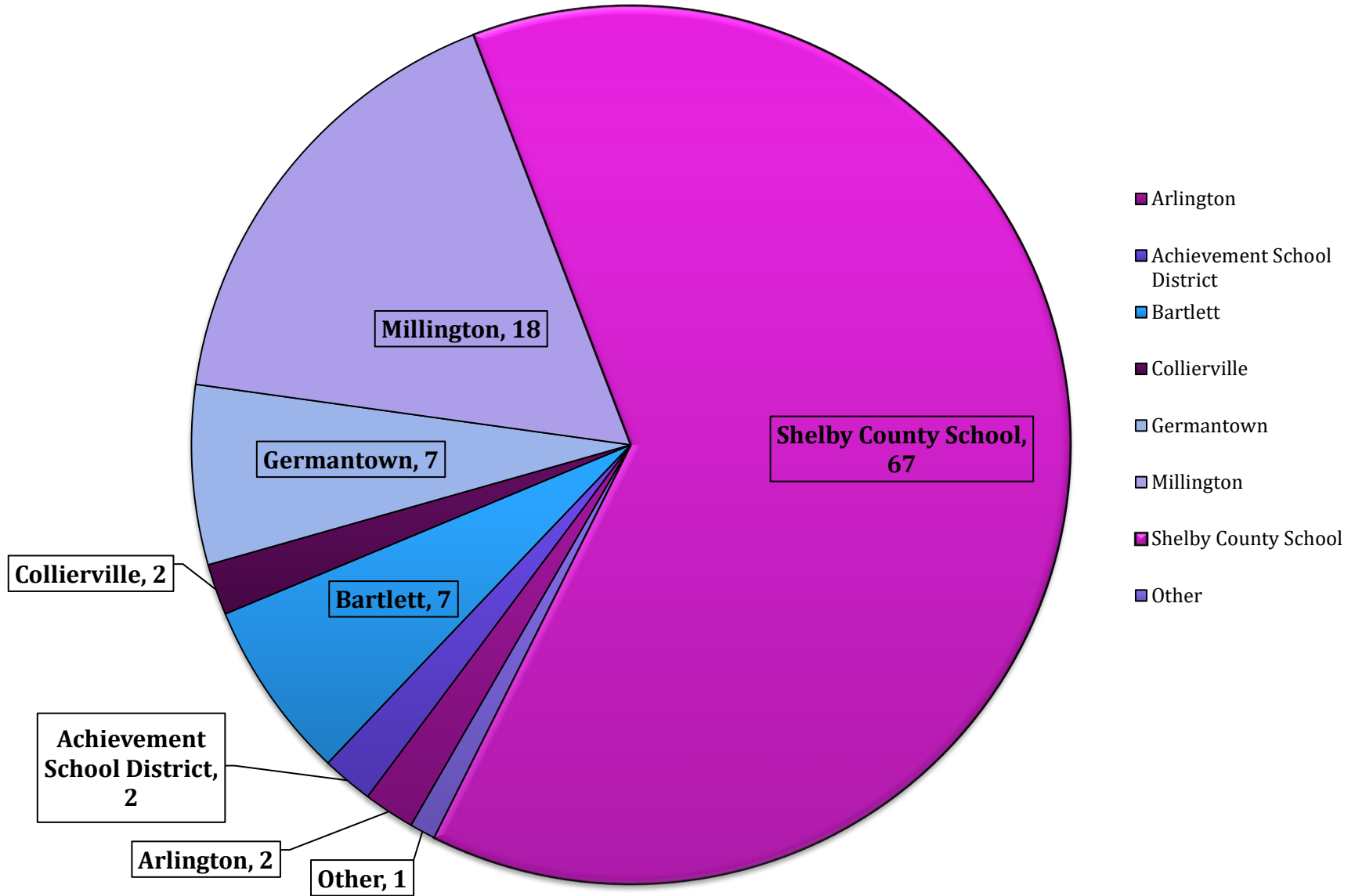


# **2021 Referral Sources** *All Children (without Summons Review Program (SRP) children)*
